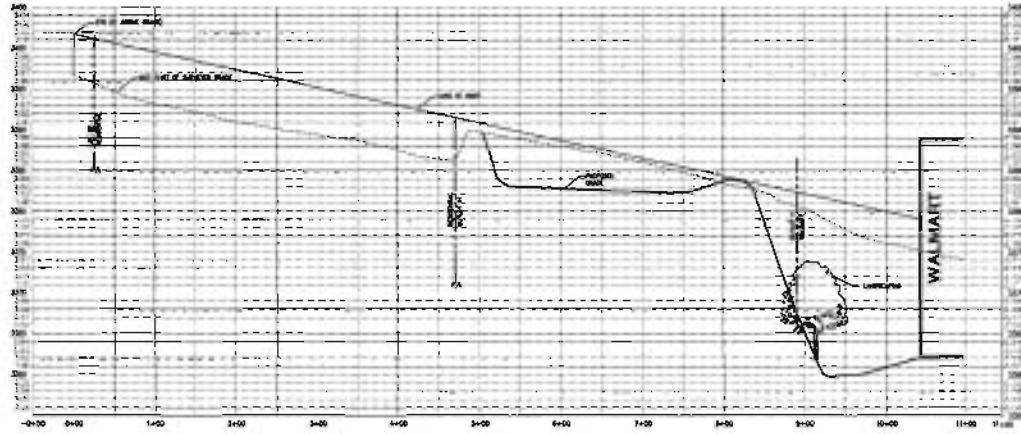

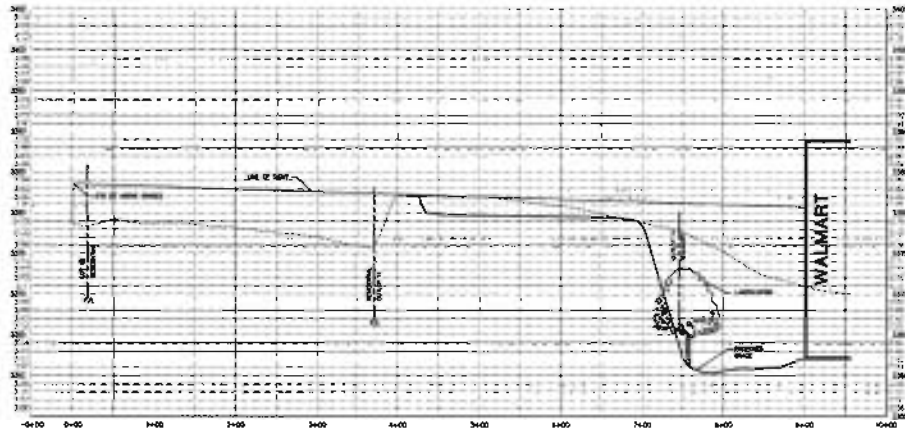

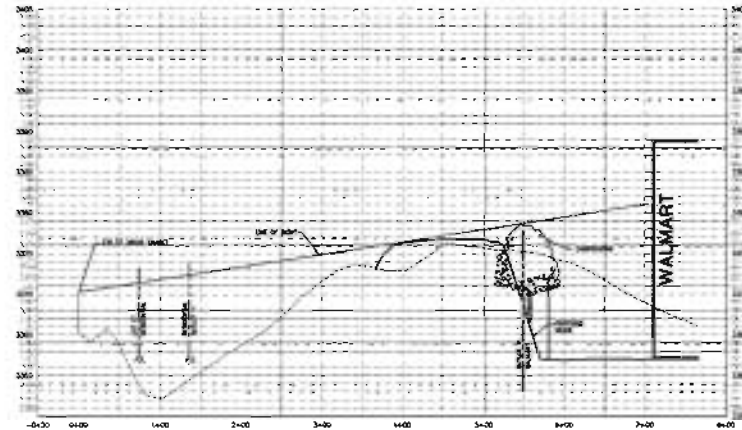

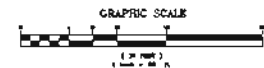


**SIGHT LINE LOT 6B**

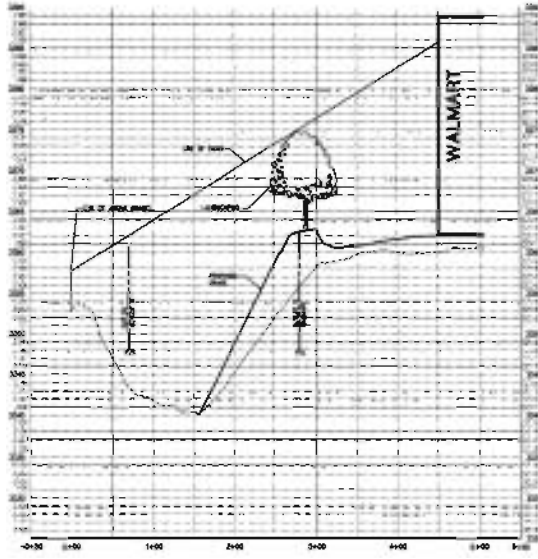

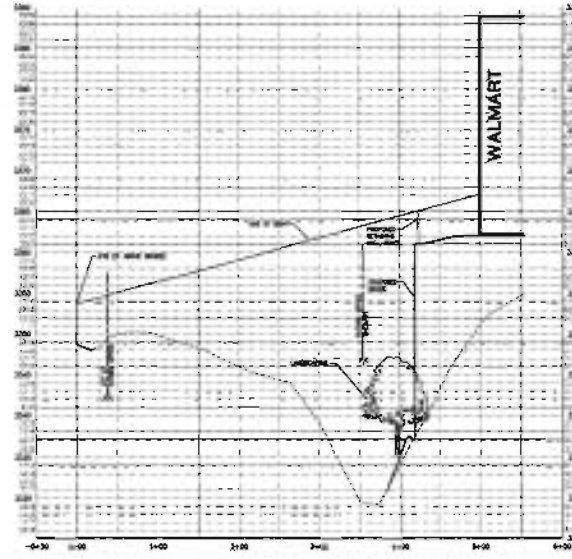

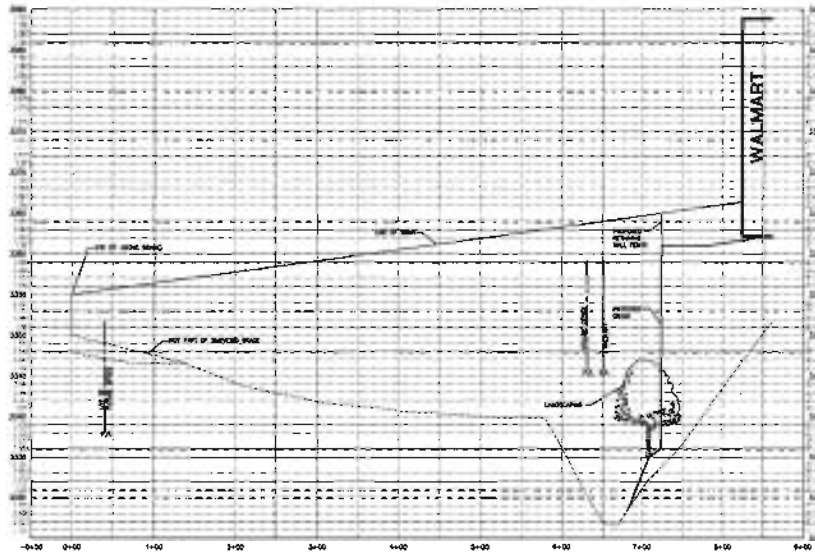




**SIGHT LINE LOT 20**

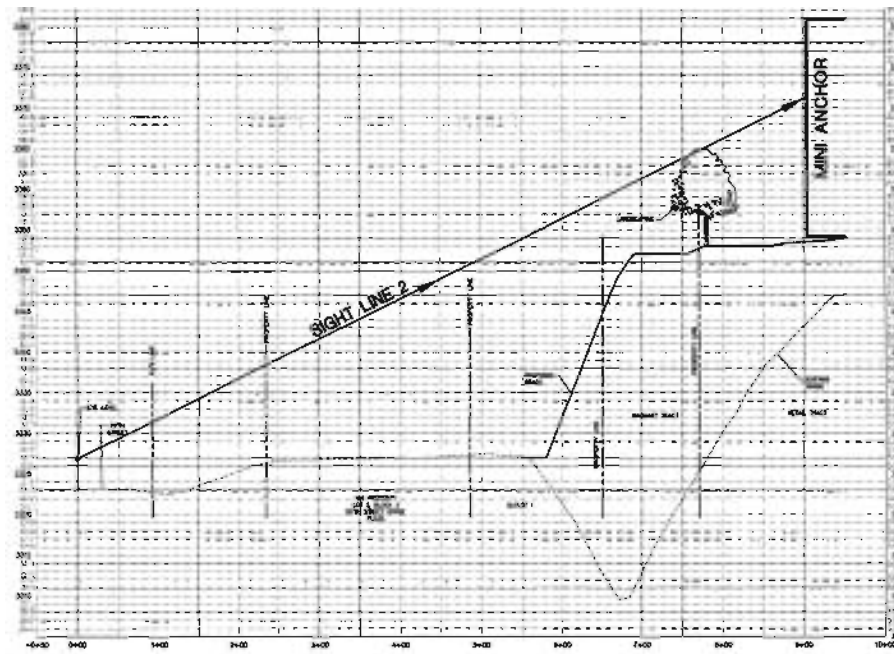
**SITE PLAN 'B'

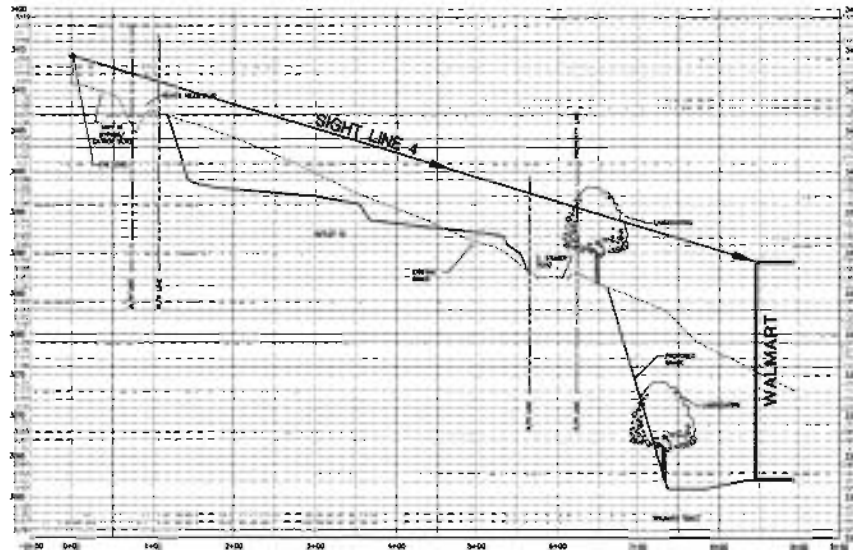
