Summary: Last year in 2010 the Parks Division entered into an agreement with Black Hills Workshop for custodial services for the parks restrooms and shelter facilities. Black Hills Workshop is again requesting consideration for renewal of their contract for 2011 in the contract amount of \$79,303.00. The contract amount for 2010 was \$ 79,303.00. After evaluation of the scope of work from 2010 (their fifth year of service) we requested Black Hills Workshop and Training Center, Inc. to extend cleaning services to Vickie Powers Memorial Park. We have been very satisfied with their service and have found their staff accommodating and easy to work with.

Recommendation: Rapid City Parks and Recreation Department staff recommends approval and acceptance of the agreement with Black Hills Workshop for custodial services for parks restrooms, shelters and recreational facilities for the 2011 season in the amount of \$ 79,303.00.
