BID AWARD SUMMARY

LETTING DATE: July 26, 2011

PROJECT: Stirling Street Sanitary Sewer Extension
Project No. SS10-1904 / CIP No. 50838

RECOMMENDATION: City staff recommends all bids for this project be rejected at the August 1, 2011 Council Meeting.

City staff has evaluated the bids for this project and has determined that it is not in the best interest of the property owners impacted by this project to make an award at this time. This project was requested by a property owner to eliminate nonconforming sanitary sewer service lines and to take advantage of the City's cost-share program. In addition to the elimination of nonconforming sanitary sewer services, this project would reconstruct city ageing infrastructure. Based on the original estimates, the amount paid by each affected property owner would have been approximately \$3,700. Based on the low bid, the amount paid by each property owner would be approximately \$6,700. City staff recommends re-bidding this project at a later date with modifications to the project schedule.


