

RESOLUTION NO. 2011-095
RESOLUTION SETTING AMBULANCE RATES

WHEREAS, the Emergency Medical Services Division of the Rapid City Department of Fire and Emergency Service is the primary EMS (ambulance) provider to the citizens of Rapid City and Pennington County; and

WHEREAS, the Emergency Medical Services Division operates as an enterprise fund responsible for supporting its operations through the fees it charges for its services; and

WHEREAS, many of the patients served by the Emergency Medical Services Division pay for their services through government reimbursement programs such as Medicare; and

WHEREAS, the Medicare reimbursement fee schedules do not fully reimburse the City for the cost of the services; and

WHEREAS, many government reimbursement agencies have adopted the Medicare reimbursement fee schedule which has reduced the amount of income to the City's Emergency Medical Services Division; and

WHEREAS, The Emergency Medical Services Division needs to raise the rates it charges in order to be able to raise sufficient revenue to cover the cost of its operations; and

WHEREAS, the City's EMS Oversight Committee has recommended that the City's EMS rates be increased by 3% in accordance with the Regional Medical Consumer Price Index (CPI) figures; and

WHEREAS, the EMS Oversight Committee is requesting the City Council adopt its recommendations and increase the EMS rates by 3%.

NOW THEREFORE, BE IT RESOLVED BY THE CITY THAT RAPID CITY, that the rates charged for EMS services be increased by 3% in accordance with the Regional Medical CPI and recommendation of the City's EMS Oversight Committee. The new rates along with the previous rates are reflected in the following chart:
