#### RAPID CITY RANGER BAND

The Rapid City Ranger Band is sponsored by the city of Rapid City through the Allied Arts Subsidy Committee. The Band consists of musicians from Stevens, Central, and private high schools who act as ambassadors of friendship for Rapid City by marching and playing in the parades and festivals in the Black Hills area throughout the summer.

Dear Mayor Sam Kooiker and members of the City Council,

The Rapid City Ranger Band has just concluded another successful summer performing in the Central States Fair Parade this past Saturday. On behalf of the student musicians, local parade chairpersons and parade spectators, we would like to thank you for your continued support of the Ranger Band. A parade is just not a parade without a marching band to set the festive atmosphere for the patrons of downtown Rapid City.

The Rapid City Ranger Band was formed at the request of the City of Rapid City in the 1950's to march one Rapid City parade during the summer. In 1959 the Rapid City Chamber of Commerce proposed to the City of Rapid City the formation of a paid marching band made up of local high school musicians to perform at the Black Hills area festivals and the Rapid City summer parades. The band has fulfilled this dream for the past 52 years. These musicians act as musical ambassadors for the City of Rapid City and are greatly appreciated by the surrounding communities.

Tourism has a major impact in the Black Hills during the summer months. Each of the major cities in the Blacks Hills area celebrates an event each year to draw attention to its community. The Rapid City Ranger Band is able to help support events such as the Central States Fair Parade in Rapid City, the Miss South Dakota Parade in Hot Springs, the Round-up Days in Belle Fourche, Gold Discovery Days in Custer, and the Days of 76 in Deadwood. The City of Rapid City is greatly admired by the community leaders' of the Black Hills for the generosity and interest shown their events by providing the one thing which is the most difficult for them to organize: a live marching band for their parade. These special events provide a reason for tourists to come to the Black Hills and pass through Rapid City on their way to one of the Black Hills events.

The Rapid City Ranger Band has fulfilled the vision set forth by the City Council in the early 1950's to help make summer parades in the Black Hills outstanding and memorable events for the thousands of tourists who visit each year. We truly appreciate your annual support for the Rapid City Ranger Band and hope we can continue to serve the community of Rapid City and provide the musical spark to an event that only a live marching band is able to provide.
