Where and when data was gathered:

- Stakeholders' meeting: September 2009
 - 80 respondents
- Mayor's retreat for Rapid City Department Heads: September 2009
 - 15 respondents
- Meeting with City Council: October 2009
 - 10 respondents
- Public input via Rapid City web page: November 2009
 - 29 respondents
- Rapid City employee feedback: October- December 2009
 - 126 respondents

Total Respondents: 260

Goal #4 -- By 2020 Rapid City will develop an interconnected parks, arts and recreation system that provides diverse opportunities for enjoyment and adds to our family friendly quality of life.

Goal #5 –By 2020 Rapid City will have in place an accessible, affordable, convenient and safe transportation system that addresses community needs.

Where are we now? Goal One

- **Goal Two: Where are we now?**
 - **The committee recommends the following:**
 - Priority One: Construct Welcome Signs at Major entrances to Rapid City
 - Priority Two: Bury Overhead Utility Lines
 - Priority Three: Remove or Reduce Billboards
 - Priority Four: More Active Code Enforcement
 - Priority Five: Construct/Repair Sidewalks, Bike Lanes and Bike trails Connecting the City.
