RESOLUTION NO. 2012-073B
RESOLUTION LEVYING ASSESSMENT FOR
BUSINESS IMPROVEMENT DISTRICT 2012

BE IT RESOLVED by the City Council of the City of Rapid City, South Dakota, as follows:

1. The City Council has made all investigations which it deems necessary and has found and determined that the amount which each lot or tract shall be benefited by the Business Improvement District 2012 is the amount stated in the proposed assessment roll.

2. The Assessment Roll for Business Improvement District 2012 is hereby approved and assessments thereby specified are levied against each and every lot, piece, or parcel of land thereby described.

3. Such assessments, unless paid within thirty (30) days after the filing of the assessment roll in the Office of the Finance Officer shall be collected by the City Finance Office in accordance with the procedure in Section 9-43-43 to 9-43-53 of the South Dakota Compiled Laws of 1967, as amended, and shall be payable in one annual installment bearing interest at the rate not to exceed five percent (5%).

Installment payment will be credited in inverse order, last installment first.
