RE: Request to waive requirement to install sidewalk per City Ordinance 12.08.060  
5160 Pine Tree Drive  
Lot 7, Block 1, Vista Hills #2, T1N, R7E, BHM, Rapid City, Pennington County,  
South Dakota

A request was received in the Public Works Office on September 14, 2012 requesting the requirement to install sidewalk per City of Rapid City Ordinance 12.08.060 be waived. This request is associated with a building permit for a detached garage. A 4 foot wide sidewalk is required to be constructed one foot from the property line along Pine Tree Drive per the Rapid City Municipal Code.

The City of Rapid City Code of Ordinances, 12.08.060 - New and existing development, section (A) states:

*"The construction of a permanent sidewalk fronting or abutting all streets, highways and avenues shall be accomplished by the builder, owner or developer of all new or relocated residential or commercial buildings within the city..."*

Section (C) states:

*"Application for variance. Any person aggrieved by any decision of the Building Official under this section may apply in writing to the Common Council for a variance from the requirements of this section."*

Therefore, as allowed by ordinance, see attached written request from the land owner to the Common Council.

The subject property is located on the east side of Pine Tree Drive, south of the intersection of Skyview Drive. The property has approximately 250 feet of frontage. The topography is hilly in this area. Pine Tree Drive is a local street with approximately 24 feet of pavement width within a variable width right-of-way (66 feet +/- on the north end of the property and 95 feet +/- on the south end of the property). The roadway is a rural section with no curb and gutter. Topography in this

area would make sidewalk installation difficult. No sidewalk currently exists on the entire length of Pine Tree Drive, and on much of Skyview Drive.

**Staff Recommendation:** Staff recommends the request to waive the requirement to install sidewalk be approved with the stipulation of signing a Waiver of Right to Protest (WORP).

Note: Rapid City Council has the authority to order in sidewalk at any time.

Re: Request to waive requirement to install sidewalk per City Ordinance 12.08.060 on Pennington County, SD, S21, T1N, R7E, Black Hills Meridian, Platted: lot 7 block 1 Vista Hills #2 more commonly known as 5160 Pine Tree Dr. Rapid City, SD.

1. No companion improvements exist for the proposed sidewalk to complement. Pine Tree Dr. has no sections of curb or sidewalk. Pine Tree Dr. is a rural road with steep embankments and guard rails that would make the installation of sidewalks nearly impossible.




