## ORDINANCE NO. 5875

## AN ORDINANCE TO CLARIFY THE BOUNDARIES OF BUSINESS IMPROVEMENT DISTRICT NO. 1 (HOTEL BID) BY AMENDING SECTION 3.24.020 OF THE RAPID CITY MUNICIPAL CODE

WHEREAS, the City of Rapid City has established Business Improvement District No. 1 to market and promote the City of Rapid City and the hotels and motels located within the district; and

WHEREAS, since its establishment, several hotels have been added to the district by Resolution of the Common Council pursuant to SDCL 9-55-4; and

WHEREAS, Section 3.24.020 of the Rapid City Municipal Code lists the properties originally included in the district; and

WHEREAS, the City desires to clarify the boundaries of the district by deleting the list of properties from the ordinance and charging the Finance Officer with keeping a list on file.

NOW THEREFORE, BE IT ORDAINED by the City of Rapid City that Section 3.24.020 of the Rapid City Municipal Code is amended to read in its entirety as follows:

## 3.24.020 Boundaries of district.

- A. The boundaries of Business Improvement District No.1 shall include all hotels and motels within the corporate limits of the City of Rapid City that have 50 sleeping rooms or more available for rent on a nightly basis. have the following boundaries, excluding any bBed and breakfast establishments, and motel/hotel properties with less than 50 rooms shall be excluded from the district.
- B. A list of all properties included in the district, which list shall identify the name of the hotel or motel, the number of sleeping rooms and each property's address, shall be kept on file in the Finance Office. The initial list shall contain all properties currently included in the district.
- 1. If a property no longer meets the criteria for inclusion in the district, the owner or proprietor of the hotel shall provide the Finance Officer with a sworn, written statement setting forth the relevant change in property or operation that disqualifies the hotel. The Finance Officer shall remove the hotel if the statement shows the hotel no longer qualifies for inclusion in the district.
- 2. Properties may be added to the district by resolution of the Common Council pursuant to SDCL 9-55-4
