The Rapid City is requesting approval to piggyback on our bid from May 29, 2012 of a new 2013 model Roll Off Truck for the MRF for purchase of a new 2014 model Roll Off Truck for the Solid Waste Collections Division. On this date, the City received and subsequently authorized and took possession of the new vehicle. Our 2013 budget contains the funding, \$150,000, for a replacement Roll Off for our Collections Division. The vendor, Eddies Truck Sales of Rapid City, has agreed to honor this bid price for a new 2014 model Roll Off truck. The total bid price is \$144,705.00.

The Solid Waste staff believes this is the most efficient and cost effective manner to proceed with the purchase of this vehicle.

- The truck will be upgraded from a 2013 model year to a 2014 model at no additional charge.
- The manufacturer of the hook lift system will honor the same price as 2012, and will be installed by Northern Truck & Equipment of Rapid City.
- Ordering the truck at this time, will give us delivery in early summer to allow us to utilize the vehicle during peak yard waste season versus waiting until last summer or early fall for delivery.
- Bidding the Roll off truck will most likely increase the cost of the unit if re-advertising for bids.
- The purchase of a like unit will assist in the maintenance of the vehicle as like units will allow for mechanics familiarity with the unit and purchase of parts.

The Solid Waste Staff believes purchasing this unit by piggybacking on the 2012 bids is in the best interest of the City.
