I am writing this in connection with Timberline Little League's request for authorization and/or acknowledgment of its annual raffle drawing to be held during the opening ceremonies. Historically, the baseball and softball players of Timberline Little League (5-12 years old) have sold raffle tickets in the community for the purposes of generating money to support the League. Timberline desires to continue that event for the 2013 season. This letter provides the relevant information on the raffle drawing.

WHAT: The League will purchase and obtain donated prizes/gift certificates from various businesses throughout the community, which prizes will be awarded based upon a raffle ticket drawing. Prizes will also be awarded to the players who sell the most tickets. I am attaching a copy of the prizes that were awarded last year, and we expect this year to be substantially similar. The League has budgeted \$2000, total, towards the purchase of prizes. Ticket holders need not be present to win.

WHEN: The raffle drawing will be held during the opening ceremonies for Timberline Little League on Saturday, May 18, 2013, between 11:00 a.m. and 1:00 p.m.

WHERE: Timberline Little League Majors baseball field.


PRICE: Tickets will be sold for the price of \$1.00, apiece.
