

## **2013 Carol M. White Physical Education Progress Grant**

### **Necessary Partnership Agreements for the Grant Application**

A Competitive Preference in the PEP grant application process is the utilization of community partners in the project. Applicants who meet the Competitive Preference Priority in their application receive two bonus points on overall evaluation. These 2 points can be key in receiving a PEP Grant or not.

The PEP Project that we are designing an application for requires the following partners and we need signatures on the following assurances to be submitted with the PEP grant application. All five partners (utilizing an Authorized Representative) must sign partnership agreements and these agreements must be included in the application.

#### 1. Local Education Agency (LEA):

- a. A public board of education or other public authority legally constituted within a State for either administrative control or direction of, or to perform a service function for, public elementary or secondary schools in a city, county, township, school district, or other political subdivision of a State, or for such combination of school districts or counties as are recognized in a State as an administrative agency for its public elementary or secondary school.
- b. The term includes any other public institution or agency having administrative control and direction of a public elementary or secondary school.
- c. The term includes an elementary or secondary school funded by the Bureau of Indian Affairs but only to the extent that such inclusion makes such school eligible for programs for which specific eligibility is not provided to such school in another provision of law and such school does not have a student population that is smaller than the student population of the local educational agency receiving assistance under this chapter with the smallest student population, except that such school shall not be subject to the jurisdiction of any State educational agency other than the Bureau of Indian Affairs.
- d. The term includes educational service agencies and consortia of those agencies.
- e. The term includes the State educational agency in a State in which the State is the sole educational agency for all public schools.

#### 2. Community Based Organization (CBO):

- a. defined as a private or public nonprofit organization of demonstrated effectiveness that:
  - 1) is representative of a community or significant segments of a community; and
  - 2) provides educational or related services to individuals in the community.

3. Local Public Health Entity

- a. is defined as an administrative or service unit of local or State government concerned with health and carrying some responsibility for the health of a jurisdiction smaller than the State (except for Rhode Island and Hawaii, because these States' health departments operate on behalf of local public health and have no sub-State unit). The definition applies to the State health department or the State public health entity in the event that the local public health entity does not govern health and nutrition issues for the local area.

4. Head of Local Government

- a. The term **head of local government** is defined means the party responsible for the civic functioning of the county, city, town, or municipality or an appropriate designee. This includes, but is not limited to, the mayor, city manager, or county executive.

5. Organization supporting nutrition or healthy eating:

- a. is defined as a local public or private non-profit school, local public health entity, health-related professional organization, or local business that has demonstrated interest and efforts in promoting student health or nutrition. This term would include, but not be limited to LEAs (particularly an LEA's school food or child nutrition director), grocery stores, supermarkets, restaurants, corner stores, farmers' markets, farms, other private businesses, hospitals, institutions of higher education, Cooperative Extension Service and 4H Clubs, and community gardening organizations, when such entities have demonstrated a clear intent to promote student health and nutrition or have made tangible efforts to do so. This definition would not include representatives from trade associations or representatives from any organization representing any producers or marketers of food or beverage product(s).
