Chief Allender:

On October 22, 2013 I received the Liquor License Renewal Application from the Rapid City Elks Club. A background of the manager identified significant issues with Dean Johannesen, who is listed as the Local Manager. Mr. Johannesen has numerous convictions for DUI, including five which were felony arrests. The latest felony arrest was on 11/17/09.

I contacted the Board of Directors for the Elks Lodge and discussed with them concerns about the license, and having Mr. Johannesen on the application paperwork.

I spoke directly with Andy Gay, who is Vice-Chairman. Mr. Gay informed me they would be removing Mr. Johannesen from the application, and he would no longer be allowed to manage the bar. He said they would be sending a letter to attach to the application outlining their corrective actions. He also advised they would be present at the upcoming City Council Meeting on November 4<sup>th</sup> to discuss in person any concerns a council member might have in regards to their application.

At this time, I am forwarding this application with the understanding Mr. Johannesen will be removed from the management team of the bar.


