



Project Financing

Water Reclamation Dept: \$1,500,000 State Revolving Fund Loan: <u>\$5,626,000</u> Total \$7,126,000

<u>SRF Loan Terms</u> 3% Interest, 20 years

<u>Principal Forgiveness</u> Possible 40% - 60%

Loan Repayment



- City will pledge City Water Department revenues for loan repayment
- Capital costs for City investment will be recaptured using a supplemental monthly charge for all customers in the East Rapid City water users region

Approximate monthly charge: \$51-\$77 month

 Supplemental charge will expire when SRF loan is paid back

User Rates



- Existing City water rates will remain unchanged.
- East Rapid City water users region customers will pay the supplemental charge plus City rates for water used.
- Current City policy is for non-city users to pay 150% of in-city rates, possible consideration of policy change from 150% to 100%.
