- 1. I PROVIDED THE COMMITTEE WITH LETTERS, PHOTOS & POSTERS.
- 2. STUMER WAS CLOSED IN 2010 BECAUSE 10 TO 12 PEOPLE REQUESTED THE COUNCIL TO CLOSE IT. NO OPPOSITION WAS AWARE OF IT. UNTIL THE COUNCIL CLOSED STUMER.
- 3. THE REAL REASON THAT LED TO THE CLOSING BEGAN IN 2007.
- 4. WHEN 6 LETTERS WRITTEN TO THE PLANNING COMMISSION BY THE FAMILIES ON THE 300 BLOCK OF ENCHANTMENT ROAD WITH CONCERNS ABOUT THE EAGLE RIDGE APARTMENTS.
- 5. THE LETTERS WERE ABOUT: DIMINISHED HOME VALUES, LANDSCAPING NOT UP TO PAR, TRAFFIC, NOISE, PEOPLE IN THE APARTMENTS LOOKING IN THEIR WINDOWS AND BACK YARDS.
- 6. FOR THE RECORD: SAFETY, NOT ONCE, WAS MENTIONED.
- 7. SO, IN 2010, WHEN THEY FOUND OUT WALMART WAS GOING TO BE BUILT IN THEIR NEIGHBORHOOD, THAT WAS THE LAST STRAW, THAT IS WHEN THE PUSH WAS ON TO GET STUMER CLOSED.
- 8. ALSO AT THAT TIME, THE COMMITTEE RECEIVED 24 LETTERS FROM RESIDENTS WHO DIDN'T WANT WALMART EITHER.
- 9. MONDAY MORNING THREE KIDS FROM ENCHANTMENT WALK 2
  BLOCKS TO THE SCHOOL BUS ON STUMER ROAD NEAR EAGLE RIDGE.
- 10. THAT BUS AND 2 OTHERS DRIVE INTO EAGLE RIDGE TO PICK UP KIDS.
- 11. MONDAY, AFTER SCHOOL THE BUS STOPS 1 BLOCK FROM ENCHANTMENT, 8 KIDS GOT OFF AND WALKED TO ENCHANTMENT, 2 OTHERS WALKED ACROSS A FIELD TO LOWER ENCHANTMENT.
- 12. ONE BUS DROVE TO ENCHANTMENT AND DROPPED OFF NO KIDS.
- 13. THREE OTHER BUSES DROVE INTO EAGLE RIDGE TO DROP KIDS.
- 14. I PHOTOGRAPHED VEHICLES USING OPEN STUMER ROAD SATURDAY ABOUT NOON, MONDAY BEFORE SCHOOL AND AFTER SCHOOL, A TOTAL OF 3 HOURS AND 50 MINUTES, 93 VEHICLES, 17 OF THE 93 WERE FROM EAGLE RIDGE.
- 15. THIS MORNING AT 7:05 AM FOR 35 MINUTES 17 VEHICLES USED THE STUMER OPENING.
- 16. FOR THE 4 1/2 HOURS, THE AVERAGE WAS 1 VEHICLE/2.4 MINUTES.
- 17. IN THE EAGLE RIDGE MANAGEMENT OFFICE, I PLACED A PETITION TO KEEP STUMER OPEN AND ONE TO CLOSE IT. THE ONLY OPPORTUNITY TO SIGN IT WAS DURING OFFICE HOURS MONDAY. THE 13 APARTMENTS BUILDING HAD TWO ENTRANCES, SIGNS WERE PLACED AT EACH OF THOSE DOORS INFORMING THEM OF THIS MEETING & THE PETITION IN THE MANAGER'S OFFICE.
- 18. 18 SIGNED TO KEEP OPEN AND 1 TO CLOSE IT.
- 19. A NEIGHBORHOOD & TAXPAYERS. PLEASE KEEP STUMER OPEN.
