I have received and reviewed your application for a Taxi license. After a review of your criminal history due to the following reasons, I have determined it is necessary to recommend denial of licensure:

- You were deceptive on the application
- Your recent drug related conviction
- Lengthy history of concerning traffic violations

If you disagree with my decision and wish to discuss this further, please arrange a time to meet with me by calling Ms. Vicki Jaco at 349-4133.

If you choose not to meet with me or if we meet and you are not satisfied, you may contact Ms. Pauline Sumption the Rapid City Finance Officer and ask that your situation be placed on the Council agenda for a hearing before the Rapid City Common Council. You must make this request within ten days of receipt of this letter and a hearing will be scheduled.

At that hearing, I will present your entire history to the Council and you will have an opportunity to explain that record.

I also believe it is my duty to inform you that you do not have a taxi license and every day that you drive a taxi without a license is deemed a separate infraction. If you should have any questions please contact me.

FINGERPRINTING SERVICES

On August 4, 2008, the Rapid City Police Department started conducting Live Scan fingerprinting services to the community. Live Scan is an inkless process where fingerprints are electronically recorded.

Fingerprinting Service Hours: Monday through Thursday; 8:00 a.m. to 4:00 p.m.; Friday 8:00 a.m. to 3:00 p.m.

Appointment for fingerprinting can only be made by calling the Criminal Investigation Division at (605) 394-4134 during normal business hours, as listed above. Payment to the Finance Office must be made and valid identification provided to the fingerprint operator before your fingerprints are scanned.

Identification Required:

You must bring a valid form of photo identification with you to your appointment. Valid identification includes a valid driver's license or State issued identification card, military ID, or a valid passport. No other forms of identification will be accepted for purposes of fingerprinting.

Fingerprinting Location:

The Rapid City Police Department Criminal Investigation Division is located on the 3rd Floor of the Public Safety Building, 300 Kansas City Street, Rapid City, SD. This building is located east of the Pennington County Courthouse.
