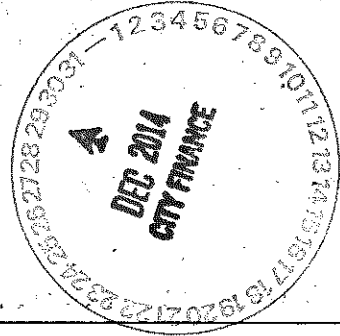


MUNICIPAL REFERENDUM PETITION IN THE MUNICIPALITY OF RAPID CITY, SOUTH DAKOTA

WE, THE UNDERSIGNED qualified voters of the municipality of Rapid City, the state of South Dakota, petition that the following resolution, as passed by the governing board of the municipality, be submitted to the voters for their approval or rejection pursuant to law.

RESOLUTION NO. 2014-118

A RESOLUTION AUTHORIZING THE ISSUANCE OF SALES TAX OBLIGATIONS FOR THE RUSHMORE PLAZA CIVIC CENTER IN AN AMOUNT NOT TO EXCEED \$180,000,000 IN CONSTRUCTION COSTS AND FURTHER AUTHORIZING CERTAIN OFFICERS OF THE CITY TO APPROVE, EXECUTE AND DELIVER AGREEMENTS AND DOCUMENTS RELATING TO THE OBLIGATIONS. PASSED BY THE RAPID CITY COMMON COUNCIL ON THE 1ST DAY OF DECEMBER, 2014.



INSTRUCTIONS TO SIGNERS:

1. Signers of this petition must individually sign their names in the form in which they are registered to vote or as they usually sign their names.
2. Before the petition is filed, each signer or the circulator must add the residence address of the signer and the date of signing. If the signer is a resident of a second or third class municipality, a post office box may be used for the residence address.
3. Before the petition is filed, each signer or the circulator must print the name of the signer in the space provided and add the county of voter registration.
4. Abbreviations of common usage may be used. Ditto marks may not be used.
5. Failure to provide all information requested may invalidate the signature.
