Meeting of the Common Council

September 18, 1989

Motion was made by Holbrook and seconded by Coffing to approve an agreement to provide that the City will pay for the waterline to the Airport, the Airport will continue with the present system of crash/fire/rescue and security services, and the fire fighters agree to forego the \$.49/hour security pay. Bailey asked about the cost of living adjustment over the next three years. City Attorney Jackson explained that the City should not decide at this time what the cost of living will be for the next three years, although there is an understanding on this issue. Carlyle stated that he would have preferred to proceed with the early retirement option rather than agreeing to pay for the waterline project at the Airport. He explained that five senior fire fighters voluntarily approached Chief Tish requesting consideration on early retirement. The six men at the Airport station could have been transferred into the City and the private security company could have been used at the Airport. Carlyle stated that this would have provided for long-term savings at the Airport. Bill Flohr, representing the fire fighters, stated that several of the fire fighters approached Chief Tish about early retirement, not because they wanted to retire, but because they didn't want the others to be laid off. Carlyle stated that several people talked to Tish about this before the issue of JJ Security was brought to the City. Flohr stated that this was not his understanding of the situation. Flohr also questioned the substantial savings that JJ Security could have provided the airport. Carlyle stated that there would not have been substantial savings in the first three years because of the buyout and start up costs, but there would be substantial long-term savings in that type of operation. Flohr stated that there is a difference of opinion on this matter. Coffing stated that the contract with a private company was only for three years and the City has no idea of what the costs for this service would have been after that. Holbrook called the question and there were no objections. Upon vote being taken thereon, the motion carried unanimously.

HEARINGS

The Mayor presented a petition to allow a Use on Review for a Utility Substation Addition, to be located on Lot "1" Revised located in the SW1/4 NE1/4 of Section 10, T1N, R7E, BHM, Rapid City, Pennington County, SD. Motion was made by Robinson, seconded by McLaughlin and carried to approve the requested Use on Review with the stipulation that the requirements of the landscape ordinance (Appendix A, Article V, Section 14, Section 14 of the Revised Ordinances of the City of Rapid City), be met.

The Mayor presented a petition to allow a Use on Review for a Family Day Care Home to be located on the east 4' of Lot 21 and all of Lot 22, Block 16, South Robbinsdale Addition, SE1/4 NW1/4, Section 7, T1N, R8E, BHM, Rapid City, Pennington County, South Dakota (830 East Oakland). Motion was made by Robinson, seconded by McLaughlin and carried to approve the Use on Review with the following stipulations: 1) That Article V, Section D.4 of Appendix A of the Revised Ordinances of the City of Rapid City be continually met; 2) that a maximum number of twelve children be cared for, and 3) that the use on review be granted for a period of one year subject to renewal to LaVon Green at 830 East Oakland.

The Mayor presented a petition to allow a Use on Review for a Family Day Care Home to be located on Lot 11, Block 2, Robbinsdale Terrace, SE1/4 NE1/4, Section 12, T1N, R7E, BHM, Rapid City, Pennington County, South Dakota (215 East Indiana). Motion was made by Robinson, seconded by McLaughlin and carried to
