We have worked with the South Dakota Housing Authority to sprinkler Governor's Houses being used in the Black Hills as vacation spots for injured veterans and their families. We have convinced many developers and long-term hotel owners to voluntarily sprinkle their buildings. Our only full-time fire and life safety educator has managed several grants and many public outreach programs. The Rapid City Fire Department's Fire Prevention division, who is spearheading this project, is successfully managing grant funds for wildland fire fuel mitigation projects protecting over \$30,000,000 in properties.

South Dakota has the 12th highest fire death rate according to the NFPA''s US Unintentional Fire Death Rates by State report October 2012. Our residents are 1.7 times more likely to die in a fire than the general national population. There are 853,175 people living in South Dakota, according to the US Census, in 370,291 housing units.

Our poverty rate is 14% (US Census) but this is misleading. The state"s a median income is just over \$45,000 while the 2012 poverty rate for a family of four was just over \$46,000. While we have many people with high incomes and upper middle class lifestyles, we have many people who are in poverty or just above. A single mom with one child, making \$2000 gross a month does not qualify for state assistance because there are too many other people with less in need.

Rural communities tend to have high death rates and South Dakota ranked as the 5th state with the most people who live in rural communities (NFPA). Depending on what US program you use to determine rural versus urban, 50 – 75 percent of South Dakotans live in rural communities.

There are seven local career fire departments in South Dakota, three federal career fire departments, and handful of federal and state career wildland fire crews. Even in our career departments, portions of their response area have a response time of over eight minutes. Our volunteer departments are often more than 15 minutes response for their first unit arrival. (NFIRS)

There are less than a dozen fire marshals in the state including county fire coordinators. There is one full-time fire and life safety educator who's duties are divided with a data quality focus. It is not possible for our small band of fire prevention officials and fire suppression staff and volunteers to believe we can continue to protect our state with our response times and the speed of today's fire without fire sprinklers in every residence. The lack of community risk reduction puts our population at high risk.

We have a conservative legislature who sticks with what they know and often do not go out on a limb for what is not currently popular or proven to be successful. Like most states, we have a law that prevents the adoption of code requiring fire sprinklers for all residential homes. Our largest city cannot mandate sprinklers in multi-family housing less than 16 units. They tried last year to get that reduced to 6 but lost. Our elected officials are vulnerable because of what they do not know or understand and more seriously, what they don't think they want to understand. We have found common ground with a few homebuilders and a few local officials to understand why the fire department is so concerned. We need something that cannot be missed to help the others at least understand where we are coming from and why we need them to discuss the actual facts and not just the fears of supposed economic impacts of fire sprinklers.

We"ve been working with plumbers, commercial installers, and independent contractors to install sprinklers at the lowest cost possible. We have developers that always install sprinklers in their projects but we also have commercial sprinkler companies that don"t need the residential work because most of their competition is working in the building boom surrounding North Dakota"s oil fields. We"ve worked with a few plumbers but we lost them to insurance costs and the expense of learning on the job.

We have worked with South Dakota Housing Authority to sprinkler some Governor's Homes that were being used on State Park property for respite for injured veterans. The project was a success. So what would sprinklers cost in all manufactured homes? \$20,000 a year. This includes all parts and labor.

There are three home designs and Residential Designs has agreed to donate three engineered sprinkler designs at a value of \$500 each for a total in-kind donation of \$1,500. This will be a one-time expense. In addition, Residential Design has agreed to donate of sprinkler installation training for their inmates and career staff.

A Governor"s Homes model home is on display at almost every county and state fair during the summer and fall. Rapid City Fire Department has agreed to donate an indoor banner from the Home Fire Sprinkler Coalition along with a video and the necessary equipment to be played in the model homes. The IFMA chapter has agreed to educate the staff of the home on home fire sprinklers. We will have donated informational materials for interested parties.

We have trailer for side-by-side sprinkler demonstrations that is funded by private donations, county fuel for towing, and the department using the trailer. A demonstration will be conducted when the state legislature meets and at least three of the county and state fairs. These locations average 300 miles from one another and the people moving the trailer will need to return home between delivery and removal.

Our state has not established a Sprinkler Coalition due to the small number of fire marshals and lack of time to coordinate on a project from scratch. With this grant we will have an easy cause to come together on and will establish the SD IFMA chapter as a founding member of the South Dakota Sprinkler Coalition.

The IFMA chapter, now a Sprinkler Coalition, will coordinate with our member departments to distribute the same message across our social media and local news media outlets. We will push hard for a week across the state when we promote the project with the state legislatures and state fair and will promote the project and live burn locally the week before and during the local fair. The staff time to coordinate and disseminate information will be donated.

Success will be measured by the number of homes with fire sprinklers after 12 months of the project in full swing. We expect to have at least 50 homes protected and hope to document more homes in the state that were voluntarily sprinklered. Success will be measured by the number of state and local elected officials that agree with the need for home fire sprinklers or are not against home fire sprinklers. We aim to convince at least 30% of the officials to indicate they are neutral or in favor of home fire sprinklers.

The first six months after award of the grant will be spent on obtaining the donated engineered designs, ordering the necessary parts, and training inmates on sprinkler installation. The SD IFMA chapter/Sprinkler Coalition will order and gather the donated monitor, video, banners, and handouts for the model home display.

The next 12 months will be spent constructing and installing the homes. A model home will be selected by the state and equipped with the donated materials and display. We will document the installation of the sprinklers to that model home and incorporate the footage between nationally provided sprinkler videos and footage of the side-by-side demonstration. The SD IFMA chapter/Sprinkler Coalition will train those staffing the model home and will coordinate live burn demonstrations and media releases with local fire departments. Elected officials and members of the community attending live burns will be polled for their support of home fire sprinklers.

Success will be measured by the number of homes with fire sprinklers after 12 months of the project in full swing. We expect to have at least 50 homes protected and hope to document more homes in the state that were voluntarily sprinklered.

Success will be measured by the number of state and local elected officials that agree with the need for home fire sprinklers or are not against home fire sprinklers. We aim to convince at least 30% of the officials to indicate they are neutral or in favor of home fire sprinklers. We will use a student response system donated by the Rapid City Fire Department to collect anonymous attitudes.

We expect to have established a state Fire Sprinkler Coalition and have at least 60% of the necessary funding for the next year secured (though our non-grant success goal is to have 120% secured.)

The ultimate cost benefit for this step towards sprinklers in all residential houses is \$21,285/853,175 state population = \$0.0249 or just over two cents per person. For the short term look, we'll be providing sprinklers for an estimated 125 people in 50 homes (\$170 per person), educating at least an additional 1,000 people with live fire burns (\$18.02 per person) and at least 300,000 in media outreach including homeowners and those who watch live burns (\$0.07 per person). So our cost benefit is somewhere between 2 cents and \$170 per person.

I can"t end this statement without sharing what you already know. The value of a huge step towards all residential homes with fire sprinklers is tough to measure and \$21,285 is not asking very much. Of course, one life saved is priceless but that"s not a fair argument in a grant. If one in 5 people will have a fire in their lifetime that is reported to the fire department (CPSC, NFPA), then 25 of the residents of this project will call 911 to report a fire. But maybe not while they live in this house. Let"s be very conservative and estimate that only one of these houses, in its entire existence – say 50 years, will have a fire that needs a fire department response. We would be protecting the occupants for only \$21,285 for 50 years.

*6e. Sustainability: Is it your organization's intent to deliver this program after the grant performance period? If so, how will the overall activity be sustained and what are the long-term benefits? Examples of sustainable projects can be illustrated through the long-term benefits derived from the

delivery of the project, the presence of non-federal partners likely to continue the effort, or the demonstrated long-term commitment of the applicant.

This funding will only get us one year of installation. We do not believe that even \$20,000 a year would be too much to fundraise if we had the staff and public interest. Our state's International Fire Marshals Association (IFMA) Chapter is dedicated and made up of 100% of the fire marshals and 50% of their staff in the state, but we still only have 13 members. We need a little seed money and some easy success to generate more interest for fundraising, changing state codes, and raising general awareness of home fire sprinklers. We believe that we could, among ourselves, raise at least \$5,000 a year. We believe with a bit of show, we could find one or two businesses that could donate the rest. We believe they are out there right now but no one seems to have the time to educate and fineness the right people. But with a showy program proven to do some good, we think it would be easier. Most importantly, we will work with elected officials and state employees to get the cost written into the homebuilding's base budget while the iron is hot. This would guarantee long-term sustainability. Either way, we are dedicated to seeing the project continue.

We have installed sprinklers in these buildings in the past to protect injured veterans on vacation in the Black Hills. We have spent the time to talk individual developers into voluntarily installing fire sprinklers their buildings. We have a conservative legislature and we have only a handful of fire marshals in the state. We are a small area but have the opportunity to do something great and use that success to springboard into a stronger coalition with the eyes and ears of elected officials and funders. This is a one-time request to accomplish something great and worthwhile. This is a one-time funding project with long-term reach; just what this funding is for.
