Per our conversation today on the proposed Comprehensive Plan Amendment for the extension of La Crosse St., to be located east of our property line.

WE the property owners would like to go on record with our objections to the planned road. We STRONGLY object to the addition of another busy road on the east side of our property as we already have a busy road on the west side of our property. The road was annexed by the city a few years ago and since that time West Nike Road has fallen into disrepair.

The road has not been maintained like it should and the patchwork continues to grow with repeated patches getting bigger and deeper. The road is falling apart at the edges; cracks are all over the road with a lot of dips. The culvert is being patched and has a dip in the road all the way across above the culvert from settling. The road ditches are never mowed except for what the property owners do around their property. The property with the red barns has a retaining pond that always floods the property. Roads are seldom plowed in the winter.

We feel if West Nike Road cannot be maintained then there is no need to build another road that won't be maintained as well. We believe the soil conditions in this area are not suitable to any road built in this area.
