

# Rapid City Planning Commission Major Amendment to a Planned Development Project Report September 24, 2015

The Development Review Team recommends that the Major Amendment to a Planned Development be approved with the stipulation noted below.


#### **Project Summary Brief**

(Update September 17, 2015. All revised and/or added text is shown in bold.) This item was continued by the Planning Commission at the September 10, 2015 meeting to allow the applicant to finish construction of the drainage improvements. Staff has confirmed that the drainage improvements have been completed. Public Works staff indicates that the improvements appear to be functional and that site restoration is complete other than backfilling and cleanup after the new sidewalk is cured. (Update September 1, 2015. All revised and/or added text is shown in bold.) This item was continued by the Planning Commission at the August 27, 2015 meeting to address drainage concerns in the area of the request. The applicant's engineer indicated that the drainage improvements were being constructed. Staff will inspect the improvements and bring forward a recommendation at the September 10, 2015 Planning Commission meeting. (Update August 17, 2015. All revised and/or added text is shown in bold.) This item was continued by the Planning Commission at the August 6, 2015 meeting to address drainage concerns in the area of the request. The applicant has submitted a Major Amendment to a Planned Development to reduce the minimum required side yard setback for a one story single-family dwelling from eight feet to five feet. A Building Permit was issued for the dwelling which was subsequently constructed too close to the north property line. The applicant has vacated the portion of the utility and minor drainage easement into which the structure encroaches.

 Planning Commission Criteria and Findings for Approval or Denial

 Pursuant to Section 17.50.050(F)5 of the Rapid City Municipal Code the Planning

 Commission shall consider the following criteria for a Major Amendment to a Planned

 Findings

 1. There are certain conditions
 A Building Permit was issued showing that all setbacks

1. There are certain conditions pertaining to the particular piece of property in question because of its size, shape, or topography:	A Building Permit was issued showing that all setbacks were being met. However, when the property was surveyed it was shown that the structure has been built encroaching into the side yard setback and a utility and minor drainage easement on the north side of the property. On January 13, 2015, a Vacation of utility and minor drainage easement was approved for the portion of the easement where the structure encroaches. In addition, the dwelling on the property to the north was also measured from the wrong pins and constructed with a larger setback from the property line ensuring that a minimum 16 foot separation is being provided between the two structures.
2. The application of these regulations to this particular piece of property would create a practical difficulty or undue hardship:	The property is zoned Low Density Residential District II which requires a minimum side yard setback of 8 feet for a one-story dwelling. The applicant is requesting a reduction in the minimum required side yard setback from 8 feet to 5 feet. On January 13, 2015, a Vacation of utility and minor drainage easement was approved for the portion of the easement where the structure encroaches. The Fire Department has indicated that since the structure to the

	north also erred in locating the correct pins on the property, a minimum 16 foot separation is still maintained, which is
	important for fire safety.
3. Exceptions to the underlying zoning district, if granted, would not cause undue hardship to the public good or impair the purposes and intent of these regulations:	The applicant is requesting an Exception to allow a 5 foot side yard setback in lieu of the minimum required 8 foot side yard setback. On January 13, 2015, a Vacation of utility and minor drainage easement was approved for the portion of the easement where the structure encroaches. This ensures that utilities and site drainage will not be impacted by the reduction in setback. In addition, the Rapid City Fire Department has indicated concurrence with the proposed setback reduction as the dwelling located on the property to the north also erred in finding the property line and has side yard setback greater than 8 feet which maintains a minimum 16 foot separation between the structures. For these reasons, staff recommends that the Exception to reduce the minimum required side yard setback from 8 feet to 5 feet be approved.
4. A literal interpretation of this chapter would deprive the applicant of rights that others in the same district are allowed:	A Building Permit was issued showing that a minimum 8 foot side yard setback was being provided. However, the property line was not correctly identified when the foundation was poured for the existing dwelling. The applicant has vacated the portion of the utility and minor drainage easement where the structure encroaches. In addition, there is a minimum 16 foot separation from the structure located on the property to the north.
5. Any adverse impacts will be reasonably mitigated:	The applicant has constructed the drainage feature which directs stormwater away from the adjacent structure and should mitigate drainage issues associated with the reduced side yard setback request. Staff has received a complaint from the adjacent property owner indicating that the proposed drainage improvements approved with the Vacation of Utility and Minor Drainage Easement application have not been constructed. The applicant has indicated that the improvements will be constructed but not before the June 25, 2015 Planning Commission meeting. As such, in order to allow the applicant the time to construct the drainage improvements and to allow staff an opportunity to inspect the improvements, staff recommends that the Major Amendment be continued to the July 9, 2015 Planning Commission meeting. The structure encroaches into the 8 foot utility and minor drainage easement on the north side of the property. On January 13, 2015, a Vacation of utility and minor drainage easement was approved for the portion of the easement where the structure encroaches. In addition, the Rapid City Fire Department has indicated concurrence with the Exception request based on a minimum 16 foot separation between the subject dwelling and the dwelling located on the property to the north.

## Findings

The applicant's engineer indicated that drainage improvements were being constructed and had not been completed. Staff will bring forward a recommendation at the September 10, 2015 Planning Commission meeting once the drainage improvements are constructed and inspected by staff. On August 12, 2015, staff met with the applicant, the applicant's engineer, and the neighbor at the subject property. The applicant indicated that the drainage channel between the properties would be re-graded and drain pipes installed in the backyard to conduct stormwater to the street. Staff will bring forward a recommendation at the August 27, 2015 Planning Commission meeting dependent upon the drainage features being constructed. The applicant has constructed the required drainage feature which will direct stormwater away from the adjacent property and should mitigate the requested side yard setback reduction. As such, staff recommends that the Major Amendment to the Planned Development be approved. It has been brought to staff's attention that the drainage improvements approved with the Vacation of Utility and Minor Drainage Easement application have not been constructed causing drainage issues on the property to the north. The applicant has indicated that the improvements will be constructed in the next couple of weeks. As such, to allow the applicant time to construct the improvements and for staff to inspect the improvements, staff recommends that the Major Amendment be continued to the July 9, 2015 Planning Commission meeting. Staff has reviewed the Major Amendment to the Planned Development to reduce the minimum required side vard setback pursuant to Chapter 17.50.050(G) of the Rapid City Municipal Code and the goals, policies, and objectives of the adopted Comprehensive Plan. In coordination with the Public Works Department and the Rapid City Fire Department, the proposed reduction in the minimum required side yard setback will not negatively impact on-site drainage or fire safety.

1.	An Exception is hereby granted to reduce the minimum required side yard setback for
	the existing structure from eight feet to five feet. Any redevelopment of the property
	shall be in compliance with the minimum required setbacks.
