The Alberts have full trust in me to enter their home on a weekly basis to provide cleaning services. If the City Board feels the need to call Diane or Ka Alberts to obtain a character witness on my behalf then I highly recommend they do so. I also have a Bachelor's Degree in Business Administration and have attached a copy for your review.

I have concern that there are multiple letters written against me from my neighbors and that three of them are employees of the City of Rapid City. I have heard back through a City employee that the complaint came from a neighbor that had a problem with the letter I wrote to them about their pet dog coming into my yard to do their business without cleaning up (owners in presence). That same neighbor has called an old "Mayer" friend to seek retaliation against me and the Mayer directed her in the complaint process. I also have to question the retaliation action if it's because I'm the only Native American living in this close neighborhood area. If I was a white person that was inside the "neighborhood click" would we be going through this whole process? My mother is a full blooded Native American who visits and stays with us often. My mother also stays in my home when we are out of town on vacations to assist the guests who are staying through Airbnb. It's not a secret that there is a lot of racial issues against Native Americans right here in Rapid City, SD as I have experienced plenty of racial acts against me while living here.

This same family across the street is obsessed with everything going on in my home, personal and business. The family members including the creepy boyfriend constantly run to the front window to watch us if we are outside working in the yard, visiting, etc. She peeks through the window blinds/curtains to watch our every move and anyone that pulls up into our driveway including guests, friends, and family.

I just wanted to express a few concern and give this character reference to show that I am a good person who works very hard for my family.
