Bids were opened on Tuesday August 11 for one new Articulated Wheel Loader and two Skid Steer Loaders for the Solid Waste Division. On Tuesday afternoon, my staff and I reviewed the bids and are submitting the following recommendations for council approval. All required paperwork has been filed with the City.

#### Articulated Wheel Loader

#### **Recommendation- Sheehan Mack Sales & Equipment- \$344,450.00**

Four Bids received, two of the four indicate that they meet all specifications as advertised.

1. **Sheehan Mack Sales and Equipment- \$344,450.00**
  - a. Met all advertised specs
2. **Titan Machinery- \$359,000.00**
  - a. Did not meet the following specs
    - i. Unable to verify six fins per inch on radiator, six fins maximum required
    - ii. Differential lock on front axle only, required on both front and rear axles
    - iii. Hydraulic pump capacity is 50 gpm, minimum 95 gpm required
    - iv. No front window platform, window access platform required
    - v. No access step to front platform, access step required
    - vi. Mid mounted access to cooling cores, corrugated grill with swing out access required
    - vii. Mid mounted access to air conditioning core, corrugated grill with swing out access required
    - viii. Halogen lights, LED lights required
    - ix. Detent setting not available from inside cab, electronically set detent from cab.
3. **RDO Equipment Co. – \$364,000.00**
  - a. Did not meet the following specs

- i. Radiator has 7 fins per inch, no more than 6 fins per inch
- ii. Entry ladder is 6 degree, Entry ladder shall be minimum 10 degree incline
- iii. Window access platform does not extend on front of loader, must have platform for operator washing of front window
- iv. No non-slip step for access to front window cleaning platform. Must have non-slip access step to platform
- v. Manual set for bucket detent for return to carry, electronically set detent from cab.

## **Two (2) Skid Steer Loaders**

### **Recommendation- RDO Equipment Company- \$99,780.00**

Four Bids received, two of the four indicate that they meet all specifications as advertised.

**1. Jenner Equipment- \$93,452.00**

- a. Did not meet the following specs
  - i. Warranty 5 year only on drive train, 5 year all parts and labor required
  - ii. No external pre-cleaner
  - iii. Stacked coolers and radiator- must be separate
  - iv. No flexible coupling direct drive- Belt driven
  - v. No adjustable chain- adjustable chain required
  - vi. Hydraulic pumps direct drive- Jenner is belt driven
  - vii. Hydraulic pump 30.5 gpm- minimum 32 gpm required
  - viii. Breakout force 6,171, required 7,350 pounds minimum
  - ix. No removable belly pan- removable pan required
  - x. Air conditioner condenser stacked with other radiators, Air conditioner condenser will be separate
  - xi. No adjustable work lights, work lights shall be adjustable

- a. Met all advertised specs

**3. Titan Machinery- \$115,800.00**

- a. Did not meet the following specs
  - i. Grid heater, glow plugs required
  - ii. No secondary air cleaner, secondary air cleaner required
  - iii. Gear pump, piston pump required
  - iv. Belt driven fan, direct drive fan required
  - v. No quick disconnect on bucket, quick disconnects that operate under pressure required
  - vi. Halogen lights, LED lights required

- a. Met all advertised specs
