

- Mr. Pataski does not have a valid driver's license. His license is revoked in the State of South Dakota.
  - Mr. Pataski has been working as an unlicensed Security Guard/ Bouncer for S&T Security since November 2014. It had recently came to my attention that he was working in the capacity as a security guard so on 9/9/15 I contacted the owner of S&T Security to advise them that he was unlicensed and that all employees that were employed as Security Guards or Bouncers had to be licensed with the City. On 9/10/15 Mr. Pataski completed his paperwork but never paid the fee for the license then on 9/25/15 Mr. Pataski paid the City license fee and on 10/6/15 was fingerprinted. During this time frame Mr. Pataski continued to work as a security guard for S&T Security working at both Family Thrift Centers, Teddy's Bar, Prairie Market and Prairie Bottle Market. I was very clear with him during his fingerprinting appointment that legally he could not work any security until he was approved and had received his City license card and if he continued he could be fined every time he was working in the capacity of a security guard/bouncer.

Dear Mr. Pataski:

It has recently come to the City Attorney's attention that you are working as a security officer in Rapid City. Rapid City Municipal Code Chapter 5.52 requires any individual or organization wishing to provide security services to first obtain a license from the city. Enclosed for your convenience is a copy of RCMC Chapter 5.52. This chapter contains more detailed information on obtaining such license, including what fees may be required, depending on the type of license sought.

If you wish to continue to engage in the business of providing security in Rapid City, you must first obtain a license in order to legally do so. Even though your employer has a merchant security license, you are still required to be licensed as an individual. You can obtain an application for such license from the Finance Office web page, located at <http://www.rcgov.org/Finance/forms-and-applications.html>.

Providing security services without a security license is a violation of RCMC Section 5.52.020, punishable by a fine up to \$500, up to 30 days in jail, or both. Please note that each day of violation constitutes a separate offense. **If you have not either applied for a security license with the City or ceased offering security services, whether through your current employer or elsewhere, by November 1, 2015, you will be issued criminal citation(s).**

**FINGERPRINTING SERVICES**

On August 4, 2008, the Rapid City Police Department started conducting Live Scan fingerprinting services to the community. Live Scan is an inkless process where fingerprints are electronically recorded.

Fingerprinting Service Hours: Monday through Thursday, 8:00 a.m. to 4:00 p.m.; Friday 8:00 a.m. to 3:00 p.m.

Appointment for fingerprinting can only be made by calling the Criminal Investigation Division at (605) 394-4134 during normal business hours, as listed above. Payment to the Finance Office must be made and valid identification provided to the fingerprint operator before your fingerprints are scanned.

*Mon 9:20 Am*

Identification Required:

You must bring a valid form of photo identification with you to your appointment. Valid identification includes a valid driver's license or State issued identification card, military ID, or a valid passport. No other forms of identification will be accepted for purposes of fingerprinting.

Fingerprinting Location:

The Rapid City Police Department Criminal Investigation Division is located on the 3rd Floor of the Public Safety Building, 300 Kansas City Street, Rapid City, SD. This building is located east of the Pennington County Courthouse.
