SUBJECT: Bid Award Recommendation-12 New Automated Collection Trucks

DATE: January 27, 2016

After reviewing the bids submitted for the *Twelve (12) New Current Model Year Automated Side Loading Refuse Collection Trucks* (Automated Collection Trucks), the staff of the Rapid City Solid Waste Division recommends for Council approval the following equipment.

Approve award of base bid with trade-in Twelve (12) New Current Model Year Automated Side Loading Refuse Collection Trucks, opened January 26, 2016, to the lowest responsible bidder, Sheehan Mack, in the amount of \$3,162,800.00.

#### Staff Recommendation:

<u>Sheehan Mack</u>- Staff recommends to award the bid to Sheehan Mack for their low qualified bid of \$3,162,800.00. There were no major exceptions and two minor exceptions from Sheehan Mack. The minor exceptions are listed below.

• Hydraulic Cylinder Warranty- Specs= 5 years hydraulic cylinder parts and labor. Sheehan exception- 1 year parts and labor, 4 year parts.



• High Back Seats- Specification call for high back driver seat. Sheehan does not supply high back seats in garbage truck cabs.

<u>All State Peterbuilt</u>- The lowest bid was received from, All State Peterbuilt, however, there were many critical exceptions to the specifications. A summary of the exceptions is listed below.

Note: \*Denotes a critical item for operation and safety for operators WARRANTY

- \*03.01- Warranty- Spec= 1 year/100% parts and labor. Peterbuilt- 1 year/100% parts/85% labor.
- \*03.04, 03.05, 03.06- Warranty- Spec= Respond to warranty calls within 48 hours. Peterbuilt- not guaranty response time, not accept fine for late response, and no alternate repair facility
- \*03.07- Warranty- Spec= Maintain or have access facility within 200 miles of Rapid City. Peterbuilt- Truck servicing facility OK, Original manufactures Rep for packer body in 350 miles in Sioux Falls.
- \*03.09- Warranty- Spec= Free towing and transportation during first 12 months. Peterbuilt- Will not provide towing or transportation.
- \*04.01- Serviceability- Spec= Replacement unit or \$100 fine if service not complete within 7 calendar days. Peterbuilt- Will not honor.
- \*05.01- Parts Availability- Spec= Parts critical to operation will be made available within two calendar days. Peterbuilt- Only guarantee four days
- \*07.01- Delivery Penalty- Spec= Guarantee delivery by date in bidder's proposal or \$100/day fine. Peterbuilt- Did not give delivery day and not honor \$100/day fine.

#### **ENGINE AND CHASSIS**

- \*08.02- Frame- Spec= Low entry cab with step height of 17" and steps internal inclosed. Peterbuilt- Steps at 18" and not internal inclosed.
- 09.01- Cab- Spec= Single Frame. Peterbuilt- Double channel frame
- 10.01- Engine- Spec= Turbocharged in line 6 cylinder, 345 HP at 1275 torque minimum. Peterbuilt- Turbocharged 370 HP at 1250 torque
- \*10.03- Engine- Spec= Engine driven 35 cfm compressor. Peterbuilt- 17.7 cfm compressor.

#### **REFUSE PACKER BODY**

- \*27.01- Capacity- Spec= Hopper shall have a minimum capacity of 4.7 cu yards. Peterbuilt- Hopper capacity 4.0 cu yards.
- 28.03- Body Specifications- Spec= Maximum height 82". Peterbuilt- Height 90".
- 28.12- Body Specifications- Spec= No inboard guide rails. Peterbuilt- Inbound rail with 10 gauge steel.
- 28.16- Body Specifications- Spec= 40 gallon minimum capacity hopper sump. Peterbuilt- 18 gallon hopper sump.
- \*30.01-Packing Mechanism- Spec= Ram type design with ¼" AR200 steel plate. Peterbuilt- 3/8" ASTM A-715 steel plate.
- \*33.18-Lifting Mechanism- Spec= In dump position, 95 gallon container will not exceed 120" above truck frame. Peterbuilt- height of container is 129".
- \*33.24-Packing Mechanism- Spec= All wire plug-ins to be shielded and protected from oil and water. Peterbuilt- Wires not shielded or protected

- \*36.01-Hydraulics- Spec= System and pump shall be 50 gallon minimum. Peterbuilt- 40 gallon hydraulic tank.
- 36.09-Hydraulics- Spec= JIC type fittings. Peterbuilt- Uses ORFS fittings
- \*36.11-Hydraulics- Spec= 3 micron filter in return tank. Peterbuilt- 10 micron filter
