The attached list details tax parcels submitted to you for consideration of abatement. Please acon these as a board, indicate approval or denial, and mail this back to the County Auditor. The parcels included here are part of a much larger spreadsheet that will be submitted as a whole to the County Commission for consideration.
Most of the reasons for abatement are that the tax parcel was purchased by a government entity and became exempt from taxes upon purchase. The abatement process is the proper method to adjust the tax bill in these situations. All of these have been saved through last year and until a tax bill is created in January and be abated. The abatement process requires approval of the Township Board and the County Commission, but the Director of Equalization and County Auditor both recommend approval.
