Attached is an Addendum to Agreement 810490 between the City of Rapid City and the South Dakota Department of Transportation for transportation planning within the Rapid City Area Metropolitan Planning Organization. This addendum extends the 2002 Unified Planning Work Program through December 31, 2003 in order to complete Task 7000 — Special Transportation Studies, which includes the Eglin Street Corridor Analysis and the Intelligent Transportation System Master Plan. Staff anticipates both transportation studies will be finished before December 31, 2003.

STAFF RECOMMENDATION: Staff recommends approval of the Addendum to Agreement 810490 between the City of Rapid City and the South Dakota Department of Transportation extending the 2002 Unified Planning Work Program through December 31, 2003.
