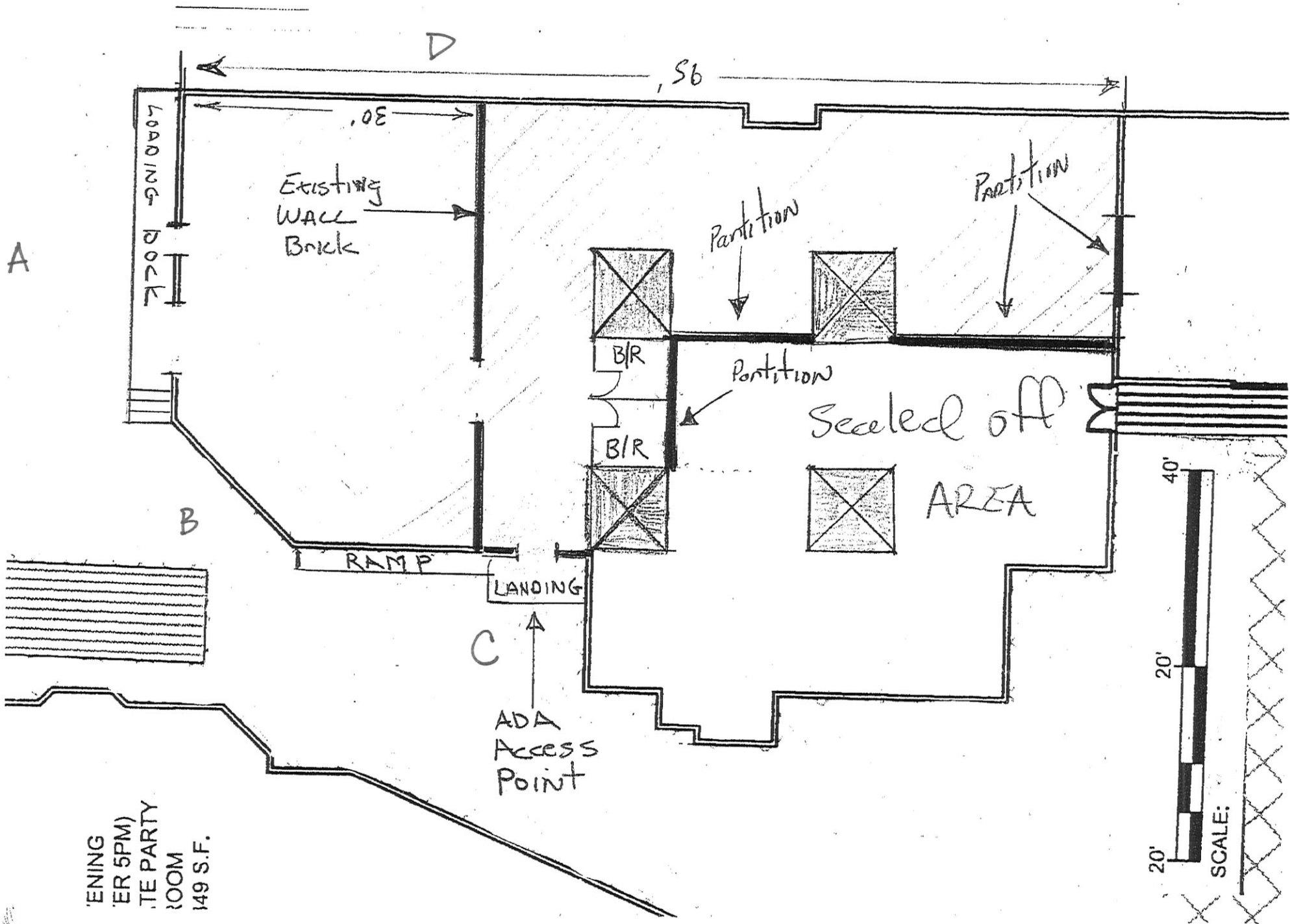


EX. ALLEY (PAVED)

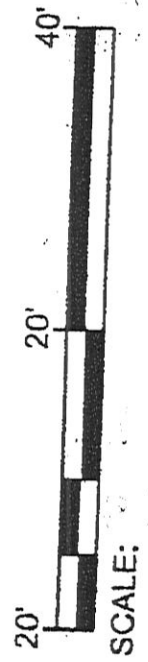

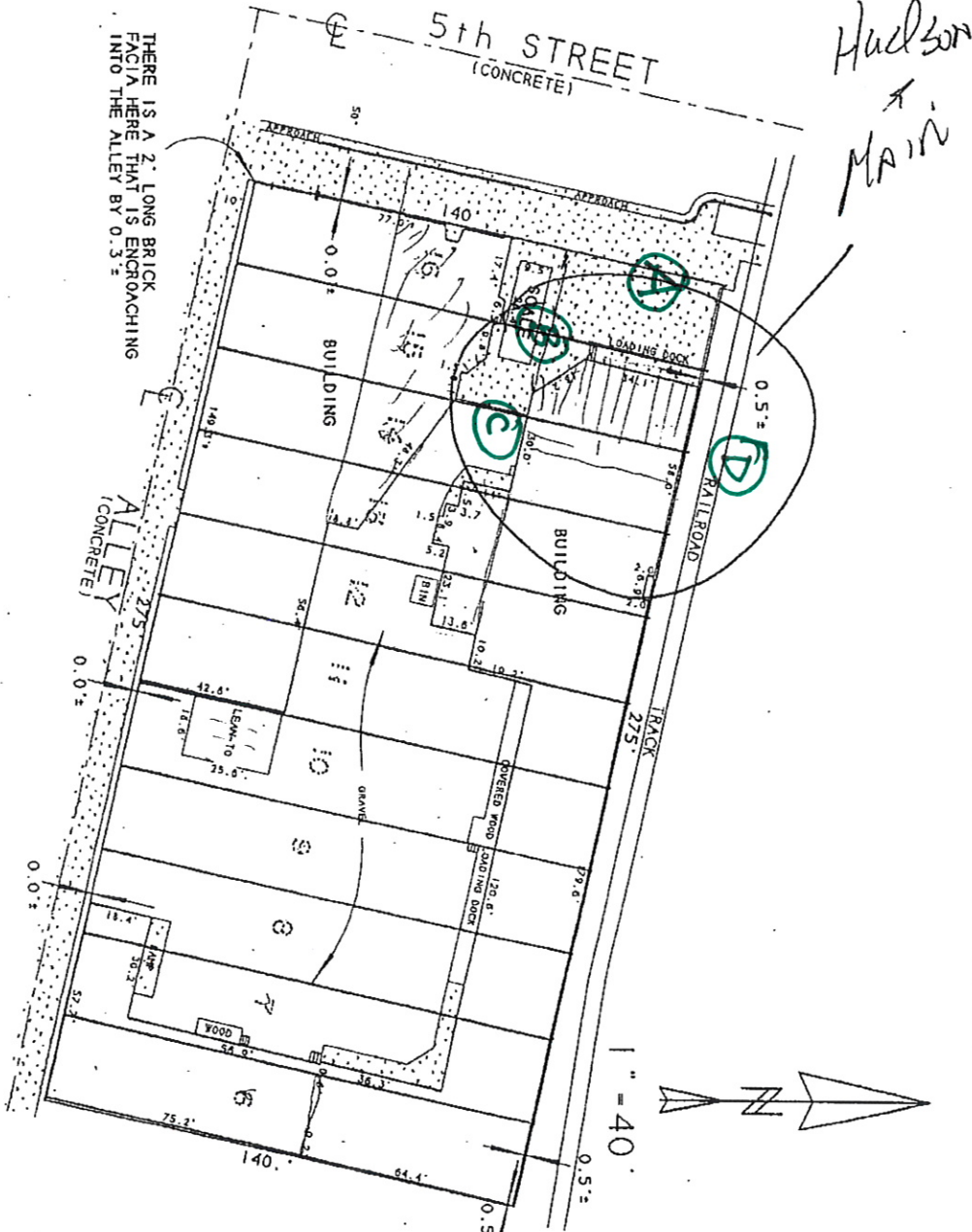
