Historic Sign Review Committee  
September 11, 2009

Mattison called the meeting to order at 8:37 am.

1320 Mt. Rushmore Road, Z-Coil – Pole Sign

**Geiger moved and Jackson seconded to approve the pole sign for Z-Coil at 1320 Mt. Rushmore Road.** Larson described the change to the face of the pole sign. Discussion followed regarding the two pole signs and wall signs located on the building. **The motion to approve the pole sign for Z-Coil at 1320 Mt. Rushmore Road passed unanimously.**

609 St. Joseph Street, Bella Boutique – Wall and Pedestrian Signs

**Jackson moved and Geiger seconded to approve the wall and pedestrian signs for Bella Boutique at 609 St. Joseph Street.** Wieseler described the sign materials and colors. **The motion to approve the wall and pedestrian signs for the Bella Boutique at 609 St. Joseph Street passed unanimously.**

505 7th Street, Lillians – Wall, window and Pedestrian Sign

**Geiger moved and Jackson seconded to approve the wall, window and pedestrian signs for Lillians at 505 7th Street.** Veneble described the signs to be located on the building. In response to a question by Mattison, Veneble explained the vinyl materials on the window sign, the painted wall sign and the sign colors. In response to a question by Geiger, Veneble stated that the font lettering on the window signs could be changed to be uniform in style. Geiger stated that the window signs would read better if the white letters were located on the window rather than on a sign with a lavender background. **Jackson moved, Geiger seconded and passed unanimously to approve the wall, window and pedestrian signs for Lillians at 505 7<sup>th</sup> Street with the stipulation that the window signs be white letters only.**

628 St. Joseph Street, Simply Style: Clothing, Bags and Shoes – Wall and Pedestrian Signs

Rutter explained that the previous name for the business at this location, Bella Boutique, is a registered name and cannot be used by this current business owner. As such, Rutter requested that the name on the sign be changed to “Simply Style: Clothing, Bags and Shoes”. **Jackson moved, Geiger seconded and unanimously approved the name change on the wall and pedestrian signs from Bella Boutique to Simply Style: Clothing, Bags and Shoes at 628 St. Joseph Street.**
