

Minutes Historic Sign Review Committee October 23, 2009

Mattison called the meeting to order at 8:50 am.

320 Main Street, Coinmach - Wall Sign

Jackson moved and Kingsbury seconded to approve the wall sign for Coinmach at 320 Main Street. Johndreau explained that the business logo has changed and the wall sign is needed to reflect that change. The sign will be made of Dibond, a composite material. The motion to approve the wall sign for Coinmach at 320 Main Street passed unanimously.

<u>932 St. Joseph Street, Legacy Jewelers – Copy Change on Signs</u>

Rutter explained that the applicant proposes to replace a panel in the ground sign with the words "Legacy Jewelers". Rutter furthered indicated that the words "Legacy Jewelers" will also be painted on the existing awning sign. Jackson moved and Kingsbury seconded to approve the copy change on the ground sign and the painted sign on the awning for Legacy Jewelers at 932 St. Joseph Street. The window sign identified in the application is an interior sign only and does not need to be reviewed. The motion to approve the copy change on the ground sign and the painted sign on the awning for Legacy Jewelers at 932 St. Joseph Street passed unanimously.

<u>508 Main Street, First Chance Games Last Chance Games – Pedestrian and Window Signs</u> Based on the original historical photograph submitted, Jackson moved and Mattison seconded to approve the pedestrian and window signs for First Chance Games Last Chance Games at 508 Main Street. Jackson stated that the sign is replicating the original sign on the building. Jackson further stated that the projection sign will need to be submitted for approval by the Sign Board of Appeals as a projection sign is not a permitted sign in the Sign Code. Koehn indicated that the lettering of the signs will be painted a gold color. Kingsbury indicated that only the building number will be located on the dark grey canvas awning. Discussion followed on the retractable awning and the potential pigeon issues. Kingsbury further indicated that the font for the lettering was selected to look very western and as close to the original sign as possible. The motion to approve the pedestrian and window signs for First Chance Games Last Chance Games at 508 Main Street, based on the original historical photograph submitted, passed with Mattison and Jackson voting yes and Kingsbury abstaining.
