AMENDMENT NO. 2 AGREEMENT FOR PROFESSIONAL SERVICES MAPPING AND GRAPHCIS SERVICES FOR FUTURE LAND USE PLANNING

The above-referenced AGREEMENT, made on the 5th day of October, 1998, by and between the CITY OF RAPID CITY, Rapid City, South Dakota, hereinafter referred to as the OWNER, and BANNER ASOCIATES, INC., hereinafter referred to as the ENGINEER, is hereby amended as follows:

- 1. The agreement date shall be extended to December 31, 2001; and,
- 2. It is understood and agreed between the parties that certain work was performed by the consultant before this amendment was approved. Further, it was the intent of the parties that the consultant perform this work and be paid in accordance with a contract. In light of the foregoing, the parties hereto ratify the acts of the consultant which may have been performed during this period of time and agree to pay for services which were performed. The effective date of this amendment shall be December 31, 2000 to December 31, 2001.

All of the terms and conditions of the AGREEMENT not specifically modified by the AMENDMENT shall remain in effect.
