SUBJECT: Training Request for Detective Sue Fox

Detective Sue Fox needs to begin her extensive training for her position as an Evidence Detective. To perform her functions with this section, there will be a variety of schools she will need to attend. In reviewing the 2001 Internation Association for Identification bulletin, there is a school being offered that would assist Sue in the transition and be a good starting point for her continued specialized training needs, specifically dealing with fingerprints.

The course is Fingerprint Pattern, Interpretation, and Identification. It is a five (5) day class, addressing issues as indicated in the title. Sue should be able to get the basic requirements prior to this class by working with and learning from Detective Plooster and Officer Jordahl.

This class will be held May 21-25, 2001, in Scottsdale, Arizona, at Scottsdale Community College. The class is limited to 24 students. Because of this limitation it is important to enroll her as soon as possible to guarantee a spot. The cost of the course is \$475.00. There will of course be transportation, which due to the distance is best suited for airline, motel, and per diem.
