Request Mayor and City Council to approve Pennington County Auditor's Office Re: to administrate the funding for Rapid City's federal 2001 Juvenile Accountability

Incentive Block Grant (JAIBG) Allocation (\$119,022).

The Rapid City Police Department has received City Council's approval to apply for the JAIBG for two years and is now making the third year application for year 2001-02. The greatest portion of funds have been allocated to the Pennington County Sheriff's Department since they are primarily responsible for supporting the Juvenile Service Center and providing treatment to juveniles. The Pennington County Sheriff's Department is in most need of the funds for various reasons.

The City's JAIBG grant has been difficult to administer since it is a cumbersome reimbursements process when having to reimburse another government entity's program that comes under our City's approved grant. For example, when the County juvenile programs are funded by the City's JAIBG, the reimbursement process works with multiple steps:

- 1. The County first submits receipts to the City Finance for reimbursement.
- 2. Second, City Finance will then send the County receipts to the South Dakota's Department of Corrections (DOC) for processing.
- 3. The DOC processes and then sends a check for the reimbursements back to the City for the County, AND
- 4. The City, once they have processed the DOC reimbursement funds, then reimburses the County.
- 5. Please be aware, that the City's Finance staff has to take the time and effort to track, process and keep an active record of all these various transactions and reimbursements for both State and Federal auditing. And, Dr. Talley, as the overall City JAIBG Grant Administrator, has to coordinate spending allocations and deadlines with the County's Sheriff's Department and State's Attorney office.

What is being requested by the Police Department is to have the Mayor and City Council agree to allow the County to administrate the program funding reimbursements for the entire City portion of the 2001 JAIBG. In short, the City will pool their JAIBG funds with the County's JAIBG funds, which will therefore only require one grant-funding administrator. The DOC will allow such pooling of funds.

The Rapid City Police Department will still receive \$5,000 grant funds for entering serious juvenile fingerprints in our automated fingerprint indexing database. However, the City by consolidating their funds with the County will avoid all the hassle of serving as a go between for reimbursements for County juvenile programs. Approving the pooling of JAIBG funds will greatly simplify the grant work for everyone without any entity loosing any funding.

In addition, it has been agreed by Sheriff Holloway that he will continue to fund two other County juvenile programs, under the auspices of the State's Attorney Office, that were approved for funding under the City's JAIBG funds:
