commercial/light industrial development in the Deadwood Avenue area north of the Interstate Highway. The project will facilitate the relocation and expansion of Black Hills Harley-Davidson/Buell. The estimated cost of the improvements is \$250,000.

Private financing will be obtained to fund the extension of water underneath U.S. Interstate 90, and will be repaid by the Tax Increment District. The applicant will be responsible for any shortfall in funding. It is anticipated that the proposed district will run for six years; however, the district may run up to 20 years to insure repayment of all project costs. The anticipated increment associated with the project is \$441,060.

STAFF REVIEW: Pursuant to the adopted Tax Increment Policy, the Tax Increment Financing Review Committee found that the proposed project complied with all applicable statutory requirements as well as the City's adopted Tax Increment Policy. Specifically, the Committee found that in addition to the mandatory criteria, the proposal met the following two optional criteria:

Criteria #1: The project must demonstrate that it is not economically feasible without the use of Tax Increment Financing.

Criteria #3: The project will not provide direct or indirect assistance to retail or service businesses competing with existing businesses in the Rapid City trade area.

Additionally, the following discretionary criteria is met:

Criteria #2: All TIF proceeds are used for the construction of public improvements.

Criteria #7: The project involves the expansion of an existing business located within

Rapid City.

Criteria #9: The project costs are limited to those specific costs associated with a site that exceed the typical or average construction costs.

Copies of the adopted Tax Increment Financing Policy are attached for your reference.

Based on the Tax Increment Financing Review Committee's recommendation, Staff recommends approval of the attached resolution approving the Project Plan for Tax Increment District Number Thirty-Four.
