The annual rental payment is based upon the equipment option circled: Caravell 306/406/SST41/SST30, Draghetto - \$50.00 annually. Once the program is agreed to and the fee is paid, forfeiture of rent occurs if Customer/Operator decides to exit program, business closes or breaches the contract. At that time the customer/operator must immediately return the UIC Equipment.					
2.	Customer/Operator agrees to purchase and stock the Equipment with only UIC products and also agrees to meet the annual sales purchase criteria of \$1300.00 in distributor dollars. Customer/Operator agrees to supply Quarterly sales information by piece of Equipment to UIC Foodservice.					
3.	Customer/Operator agrees to maintain this Equipment in good working condition and return the Equipment, upon request, to UIC. UIC will not be responsible for non-mechanical repairs.					
4.	Customer/Operator shall be responsible for the Equipment while in their possession and for any loss or damage that occurs during that period and the Customer/Operator shall immediately pay UIC the current replacement cost of the Equipment.					
5.	Title to and ownership of said Equipment is expressly retained by UIC. If the Customer/Operator goes out of business, sells the business or breaches this agreement then the Customer/Operator is immediately responsible for the return of the Equipment to UIC.					
6.	Any Equipment repairs that may be required must be made through the authorized Unilever Ice Cream repair service, Konop Refrigeration at 1-800-333-2752.					
7.	UIC may at its discretion, with notification in writing, raise the annual rental one time but by no more than 25% during the life of this contract.
