RE: Addendum to Agreement 310694 for the Rapid City Area Metropolitan Planning Organization 2000 Unified Planning Work Program

Attached is an Addendum to Agreement 310694 between the City of Rapid City and the South Dakota Department of Transportation for transportation planning within the Rapid City Area Metropolitan Planning Organization. This addendum extends the 2000 Unified Planning Work Program through December 31, 2004 in order to complete Task 7000 – Special Transportation Studies, which includes the US Highway 16 Corridor Analysis. Staff anticipates the US Highway 16 Corridor Analysis study will be finished by December 31, 2004.
