RE: Addendum to Agreement 810490 for the Rapid City Area Metropolitan Planning Organization 2002 Unified Planning Work Program

Attached is an Addendum to Agreement 810490 between the City of Rapid City and the South Dakota Department of Transportation for transportation planning within the Rapid City Area Metropolitan Planning Organization. This addendum extends the 2002 Unified Planning Work Program through December 31, 2005 in order to complete tasks included in the Professional Services/Consultants section of the Unified Planning Work Program. Staff anticipates the task will be finished before December 31, 2005.
