Subject: Swim Center Staff Training Expense

Purpose: To Approve Funding for Swim Center Staff Training

**Discussion:** The Rapid City Swim Center opened on May 29, 2004 with only one certified pool operator whose experience was with outdoor pools. The operations of indoor pools are totally different because of the controlled indoor environment. Pool chemistry is more critical, especially on a new surface because chemicals don't dissipate as readily. Tile pools have to be maintained at smaller tolerance levels so the water does not eat away the title grout. We also have a new type of filter medium that requires special servicing; currently our people have no training in this area.

**Recommendation:** We are requesting approval of funding in the amount of \$2,500 to bring in a National Certified Aquatic Facility Operator Trainer. Funding for this project is currently available in the 2004 Aquatics budget. The trainer would provide a two-day training course for eight or more city employees. We would also open the course to communities in the surrounding area at a cost of \$250 per person to attend. We have tentative commitments from Sturgis and Ellsworth Air Force Base with possible attendees from Belle Fourche and the YMCA.
