Subject: Approve Rapid City Racers Swim Team Contract for Horace

Mann Pool

Purpose: For the Mayor and Finance Officer to sign a contract to allow the

Rapid City Racers Swim Team to use Horace Mann Pool during

the summer of 2005.

Benefits: This contract will allow the Racers to practice at Horace Mann

Pool freeing up lanes at the Swim Center during the summer months. Also, the contract allows them to host a swim meet over the 4 of July weekend which is a major fund raiser for the team. These practice times and meet will not impact the usage of Horace

Mann Pool by the public.

**Recommendation:** Approve the contract.

## **AGREEMENT**

AGREEMENT MADE THIS	day of	, 2005, by and
between Rapid City Racers Swim Club, Inc.	, hereinafter referred to	as "Racers", and the
City of Rapid City, hereinafter referred to as '	'City".	

FOR AND IN CONSIDERATION of the mutual benefits to accrue from the performance of the covenants herein contained the parties hereby agree as follows:

- 1. <u>Purpose</u>. The purpose of this agreement is to set forth the terms and conditions whereby the Racers contract to organize, supervise, and conduct a competitive swim team program at Horace Mann Swimming Pool.
- 2. <u>Racer Obligations</u>. The Racers shall provide a qualified coach/ supervisor and will organize, supervise, and conduct the Rapid City Racers Swim Program at Horace Mann Swimming Pool outlined herein. The program is scheduled to consist of two practice sessions between 7:30 a.m. to 9:30 a.m., five days per week, with five (5) lanes per practice day, and two (2) lanes from 4:30 until 5:30 pm Monday, Tuesday and Thursday beginning June 20, and ending on August 12 2005.

The Racers shall also have full use of all Horace Mann Swimming Pool facilities to host competitive swim meets July 1, 2 and 3, 2005. The Racers shall be charged a reduced rental fee of \$800.00 for the season, which includes practice times. The Racers will be charged \$3.00 per person rental fee for multi-day swim meets, as these costs are not included in the basic rental agreement. The Racers shall assign a Meet Director responsible for all aspects of the meets including safety rules and closure because of inclement weather. Guidelines provided by the City Aquatic Manager for set up and clean up shall be followed.

The swim club members are not required to purchase a City season swim pass. The Racers shall be responsible for all promotion, registration, record keeping, recruiting of staff, supervision of staff and programming. The Racers shall provide payment to the City for the rental within ten (10) days of the last practice.

The Racers may not on the grounds of race, color, sex, creed, religion, ancestry, national origin or disability discriminate nor permit discrimination against any person or group of persons in the use of the Horace Mann Swimming Pool for swimming competition in any manner prohibited by local, state or federal laws. The Racers further agree to comply with the requirements made to enforce the foregoing which may be required of or by the City.

The Racers agree to leave the premises at 9:30 a.m. each day in as good condition as found at 7:30 a.m. of such day.

The Racers will be liable for any and all damage done to any part of the City's property caused by the program while the Racers are on the premises.

3. <u>City Obligations</u>. The City will provide access to Horace Mann Swimming Pool during the program schedule stated above. The City will provide maintenance to ensure the pools are available to the Racers by 7:30 a.m. each day during the program period.

4. <u>Insurance</u> . The Racers agree to hold the City harmless from any and all liability arising from any operation under this Agreement and to purchase and maintain at its sole expense bodily injury and property damage insurance for each occurrence of injury or damage in the minimum amount of One Million Dollars (\$1,000,000) single limit for bodily injury or property damage. The City shall be named an additional insured in said policy or policies and the Racers shall furnish, before the program begins, to the City evidence of insurance by a certificate of insurance of required coverage.			
5. <u>Term.</u> The term of this agreement shall end on the 31 of August 2005			
6. <u>Assignment</u> . This agreement shall not be assigned nor any rights thereunder assigned or sublet by the Racers without a written consent of the City.			
7. <u>Termination</u> . If either party shall fail to perform any of the obligations established by this agreement, the agreement may be terminated by the other party upon Ten (10) days' notice in writing thereof, provided that if the Ten (10) day period expires during the Racers Swim Program, this agreement shall terminate at the end of such program period.
