AGREEMENT BETWEEN THE CITY OF RAPID CITY AND DOECK, LLC. FOR THE COMPLETION OF SUBDIVISION IMPROVEMENTS.

This agreement is made and entered into by and between the City of Rapid City, herein after referred to as the "City," and Doeck, LLC., herein after referred to as the "Developer."

WHEREAS, the Developer is seeking approval of a final plat for Brookfield Subdivision Phase 1B, legally described as:

Lots 24 through 61 of Block 1, Brookfield Subdivision, located in the NE ¼ of the SE ¼ of Section 13, T2N, R7E, BHM, Rapid City, Pennington County, South Dakota.

WHEREAS, the Developer has submitted a bond to secure the completion of the required subdivision improvements for this subdivision; and

WHEREAS, the City is requesting that the Developer provide a date by which the required improvements will be completed, or if they are not, the City can draw on the bond; and

WHEREAS, the Developer is willing to provide a final date for completion of the improvements so that the City will accept the bond which is a requirement for approval of the final plat.

NOW THEREFORE, the parties agree as follows:

- 1. The Developer agrees to complete the required subdivision improvements on the above described property by July 10, 2008.
- 2. If the required improvements are not completed by July 10, 2008, the parties agree that the City has the option, if it so chooses, to draw on the bond and complete the improvements. The City will notify the Developer prior to drawing on the bond and will provide the Developer with a reasonable amount of time to complete the remaining improvements.
- 3. In exchange for the Developer's agreement to the terms contained in paragraph 1 and 2 of this document, the City agrees to accept the bond submitted by the Developer.
- 4. The parties' rights and obligations under this Agreement shall be governed by, and construed in accordance with, the laws of the State of South Dakota. Any dispute concerning this Agreement shall be venued and litigated in the Circuit Court for the Seventh Judicial Circuit, located in Rapid City, Pennington County, South Dakota.
