### LOCAL GOVERNMENT ENTITY AUTHORIZED USER AGREEMENT LE080206-31

Verizon Wireless and the City of Rapid City South Dakota (the "Customer") have entered into a WSCA Price Agreement, (#11-00115) (the "Master Agreement") pursuant to which this Local Government Entity Authorized User Agreement (the "User Agreement"), dated 08 / 07 / 2006, is made a part thereof.

In accordance with the definitions, terms and conditions set forth in the Master Agreement, authorized local government entity users ("Authorized User") may purchase wireless services and products under the terms, conditions, and pricing established by the Master Agreement for Authorized User participation. Participation is further subject to any and all applicable local purchasing statutes and ordinances. The Authorized User states, acknowledges and agrees, as follows:

- (1) Authorized User Legal Name: City of Rapid City South Dakota;
- (2) It is an Authorized User as defined under the terms of the Master Agreement;
- (3) It is eligible, and desires to purchase wireless services and products from Verizon Wireless pursuant to the terms and conditions of the Master Agreement and this User Agreement, and any and all addenda and schedules as the Customer may specify from time to time;
- (4) Authorized User will provide documentation and substantiate Authorized User status as appropriate and as requested from time to time by Verizon Wireless;
- (5) Authorized User will ensure that this User Agreement will be used only in support of government business;
- (6) The undersigned is designated and granted authority to act on behalf of the Authorized User for any and all matters contemplated by Authorized User; and
- (7) The undersigned is duly authorized by the Authorized User to designate the following individual(s) (the "Authorized Contacts") who are authorized to take action with respect to the account with Verizon Wireless to purchase equipment, add lines of service, cancel lines of service and make changes to the account that financially bind the Authorized User to the terms and conditions of this User Agreement, the Master Agreement, and execute Verizon Wireless Customer Agreements for the lines of wireless service, subject to the additional terms and conditions therein.

This plan has unlimited nights and weekends, unlimited calling between Alltel customers and My Circle numbers, nationwide toll free calling. The roaming rate is \$0.59 per minute plus \$0.40 for long distance when not on Greater Freedom network. All plans include Mobile to mobile, call forwarding, conferencing, waiting, basic voice mail and caller ID.

My Circle for Business allows for our account to have up to 10 numbers that we can call with our unlimited mobile to mobile minutes free of charge. These numbers will apply to everyone on the account, not by cell phone number. For example, I can not have 10 numbers that are included in my circle and you can not have 10 different numbers in your circle; the 10 numbers must be the same on every phone.

Both the National Freedom plan and the Greater Freedom plan pool anytime minutes with those on the same plan.

The City of Rapid City can choose to remain on the current plans. All new activations will be placed on one of the Alltel Freedom plans.

Alltel will offer a 15% discount on all equipment.

#### BlackBerry --

Alltel offers several BlackBerry options. The minimum server cost is \$2,999.00. This would allow only one user. It is expandable to allow beyond 15 users but additional licenses would have to be purchased. The cost of the licenses vary depending on the number of users. An additional server was offered in the proposal. The cost of this server is \$3,999.00 and would allow for 20 licenses. If more than 20 licenses are needed, there are additional fees.

#### Touch2Talk ---

Allows "walkie-talkie" type conversation. Only 2 phone options for this capability.

Alltel has a spare phone policy. This requires the City of Rapid City to purchase a small stock of extra handsets. These could be used in emergency situations when a phone was needed immediately.

Getting replacement equipment, accessories, activating new phones will be handled through email to Veronica; as it is now. If a phone needs repair and is under warranty, the individual can go to the store to have the phone sent in to be repaired. This seems to be the only time we are allowed to go to the store for any issues.

The phone prices will vary. There could be a deal this month on a phone where the cost would be \$0.99, but there could be no deals for the month and the cost would be \$150.00.

The Alltel Business 2 Business provides online maintenance of the hierarchy, printing statements, generating reports, adding and deleting features, changing ESNs.

Verizon is offering the America's Choice for Business Calling plans as options for our monthly plans.

Verizon will offer an 18% discount on the plans listed below.

Push to talk - additional \$10.00 monthly access fee per line

Tri-mode phones - Verizon has offered 2 phones at no charge, 5 phones less than \$50, and 2 additional phones less than \$80.

Dual-Band phones - Verizon has offered one phone at no charge, 5 phones less than \$50, 4 phones less than \$80, 3 less than \$150, and 3 less than \$370.

Several PDA phone options are presented. The smallest price is \$110; the highest is \$570. BlackBerry Enterprise Server cost is \$4,099, this includes 20 licenses. Additional license costs vary depending on the number of additional users.

The price for BlackBerry plan would be \$84.99 a month. This is \$44.99 for the voice portion and \$40.00 for the data portion (unlimited data). Both of these numbers are subject to discounts. The voice portion will have an 18% discount and the data a 20% discount. The total would then be \$66.89 per month for a voice/data option plan.

Verizon has offered a 25% discount off of the retail price of all accessories.

Verizon has offered their IBAS (Internet Billing Analysis System). This allows for viewing of individual phone information, maintaining and creating reports to analyze all of the data, review costs, etc. Access is limited to a few core people in the finance office.

If Verizon is chosen and the minimum plan is chosen, the number of pooled minutes for the entire City to use would be 96,750 (450 minutes x 215 phones). The cost in this scenario would be \$7,931.35 per month. This is based strictly on the price of the basic plan times the number of phones that we currently have. If a different plan or new phones are added, this price will increase.

7/18/2006 In speaking with Rick, He indicated that if the City has a Microsoft exchange 2003 server, we can use many different types of PDA options, not just the BlackBerry. He believes that we would be able to use a BlackBerry on the Microsoft Exchange 2003 server but not vice versa. If we do not have a Microsoft exchange 2003 server, we can purchase one. The cost of one of the servers is \$2,000. If we purchase 10 units (or PDAs), they will give us the server for free. The server has the capability of 1500 users and provides for more security options. The person that has access to the server control (an IT individual) will be able to cnacel service to a PDA if the unit is lost or stolen. Verizon will be doing an upgrade to their system this week which will provide these better options.
