REQUEST FOR RELEASE OF FUNDS

On or about October 6, 2006 the City of Rapid City will submit a request to the U.S. Department of Housing and Urban Development for the release of funds under Title I of the Housing and Community Development Act of 1974 (PL93-383) for the following project:

PROJECT/PROJECT SUMMARY: To construct a separate building from the church to provide and enhance recreational and social activities to underprivileged youth in the North Rapid area. The project includes a full size gymnasium to be used as a multipurpose recreational facility. A 100 foot x 20 foot area within the structure will be used for the North Rapid After School program, and a lower level will be finished for future use as programs develop. The dimensions of the finished facility will be 88 feet by 100 feet.

LOCATION: Lot C-2 and ½ vacated Marshall Blvd of Marshall Heights Tract, Section 30, T2N, R8E, BHM, Rapid City, Pennington County, South Dakota; more generally described as being located at 1404 N. Maple Avenue,

SCOPE OF WORK: Construction for an 88 ft. x 100 ft. multi-purpose recreational facility for youth.

ESTIMATED COST: \$650,000

CDBG FUNDS REQUESTED: \$25,000

FINDING OF NO SIGNIFICANT IMPACT

The City of Rapid City has determined that the project will have no significant impact on the human environment. An Environmental Impact Statement under the National Environmental Policy Act of 1969 (NEPA), therefore is not required. Additional project information is contained in the Environmental Review Record (ERR) on file at the Community Development Division, 300 Sixth Street, Rapid City, SD, and may be examined or copied weekdays from 8:00 A.M. to 4:00 P.M.

PUBLIC COMMENTS

Any individual, group, or agency disagreeing with this determination or wishing to comment on the project may submit written comments to the Rapid City Community Development Division. All comments received by October 6, 2006 will be considered by the Rapid City Community Development Division prior to authorizing submission of a request for release of funds. Comments must clearly specify which Notice they are addressing – the Finding of No Significant Impact or the Request for Release of Funds.

RELEASE OF FUNDS

The City of Rapid City certifies to HUD that the Mayor and his designee in his/her official capacity, consent to accept the jurisdiction of the Federal Courts if an action is brought to enforce responsibilities in relation to the environmental review process and that these responsibilities have been satisfied. HUD approval of the certification satisfies its responsibilities under NEPA and related laws and authorities, and allows Bethel Assembly of God for the North Rapid Youth Center to use Program funds.

OBJECTIONS TO THE RELEASE OF FUNDS

HUD will accept objections to its release of funds and the City of Rapid City's certification for a period of fifteen days following the anticipated submission date or its actual receipt of the request (whichever is later) only if they are on one of the following bases: (a) the certification was not executed by the Certifying Officer of the City of Rapid City; (b) the City of Rapid City has omitted a step or failed to make a decision of finding required by HUD regulations at 24 CFR Part 58; (c) the grant recipient has committed funds or incurred costs not authorized by 24 CFR Part 58 before the approval of a release of funds by HUD; or (d) another Federal agency pursuant to 40 CFR Part 1504 has submitted a written finding that the project is unsatisfactory from the standpoint of environmental quality. Objections must be prepared and submitted in accordance with the required procedures of 24 CFR Part 58, and may be addressed to U.S. Department of Housing and Urban Development (HUD), Region VIII Office, 8ADE, 1670 Broadway Street, Denver, Colorado, 80202-4801.
