Dear Mr. Jason Green:

The Rushmore Curling Club is providing you written notice of its intent to conduct a raffle pursuant to the requirements of section 5.20.020 of the Rapid City Municipal Code. See below for all the pertinent details following the format of the municipal code.

A. The full legal name of the organization is the Rushmore Curling Club (RCC). RCC was incorporated as a non-profit entity on March 25, 2003 in Rapid City, SD.

B. I, Brian Madden, President, am applying on behalf of the RCC.

C. The RCC mailing address is PO Box 3313, Rapid City, SD 57709. The principal place of operations has been the Roosevelt Ice Arena, Rapid City, SD.

D. The class of exemption describing the organization is "(6) Local civic or service club."

E. Please see the SD Secretary of State's website which shows our organization's ID number as NS012264 (non-profit) at the following address

F. The entire net proceeds of the raffle will be devoted to RCC's operational expenses and debt retirement.

G. RCC intends to conduct the raffle drawing at the Roosevelt Ice Arena. Tickets will be sold by various members throughout the community.

H. The drawing date for the raffle will be May 5, 2007.

I. The persons who shall conduct and maintain the integrity of the raffle will be the Board of Directors of the RCC and are: Brian Madden, Dann Nankivel, Cheryl Nankivel, Aaron Carr, Herb Kistler, Wendy Kloeppner, Mike Banton, and Scott McDonald. Other members of RCC will assist in selling raffle tickets.

J. No compensation will be provided to anyone in connection with the conduct of the raffle.

K. I, Brian Madden, certify that the proceeds from this raffle will not inure to the benefit of any individual.

L. I, Brian Madden, certify that the following conditions will be met by the RCC:

1. RCC will not conduct more than 2 raffles within 1 year of authorization;
2. That the aggregate net proceeds will not exceed \$75,000 during the 1 year authorization;
3. That the raffle drawing will not be conducted off the premises of the principal place of operation.

M. The prize RCC intends to award will be:

- (1) a 42 inch plasma television with an approximate value of \$1,100 or \$1,000;
- (2) a two night stay at Cadillac Jacks and meals with an approximate value of \$200;
- (3) a choice of one of the following: one annual membership to the Rushmore Curling Club for the 2007-2008 season with a value of \$240 or one team entry in to the RCC's 2008 Granite Faces Bonspiel with a value of \$160;
- (4) a hotel room and four passes to the Watiki Water Park with an approximate value of \$150.

The manner of award will be by a random drawing of the sold raffle ticket stubs on the evening of May 5, 2007.

N. This information will be provided if requested by the Rapid City Police Department.

O. The bookkeeping will be kept to accurately account for all sales of raffle tickets. A weekly reconciliation will be done to ensure that the proceeds received equals the number of tickets sold times the price of the ticket. Monthly and annual reports will be provided to the Rapid City Finance Officer.
