### Purpose of Grant request:

#### Our grant request has NO contingency request as in past grant applications.

MAIN GRANT PLAN: Granted funds will solely be used to plant trees, shrubs, and vegetation in parks and areas deemed appropriate by our Committee in concert with the City Parks & Rec Department. The intent is to plant new trees, shrubs, and vegetation in areas seeing died-offs and in new areas being designed.

Our past grants have been contingent upon Federal Highway Administration approval for 4:1 matching funds, but because this process has been long, long overdue, this committee wishes to see immediate results impacting the beauty of this area, and will direct that these funds will be spent in 365 calendars days once received. As chairman of this committee, I will direct their expenditures.

This grant will also see additional trees and vegetation in the downtown areas and vegetation which can survive in our drought-like conditions will be place in our present "Welcome to Rapid City" signage areas. We will also earmark some funds for planting materials at the new "Welcome to Rapid City" sign now in design and to be located on the south-east approach at the Catron Boulevard and S Hwy 79 bridge for visitors to see approaching the city from the south.

This committee has lobbied long and hard for a welcome sign placement at this bridge access area and DOT has approved our request to do so. There is irrigation at this location and no monies will be spent for any infrastructure. This newly designed sign will replace the old welcome sign removed during the S Hwy 79 reconstruction project.

This committee has always appreciated the Gwendolyn Stearns Foundation support and we intend to see that these monies will be completely spent within the calendar year following your approval.
