RE: Historic Preservation Commission Grant
Additional Funding of Projects

The Historic Preservation Commission requests approval of Amendment #2 to State of South Dakota Historical Preservation Allocation Award for Preservation Project SD-07-21. The amendment will increase the federal share in the Workshop line item to be funded from the 2007-2008 CLG Grant. The requested amendment will allow additional funding for the Home Show in the amount of \$471.75. Matching funds from the City of Rapid City is required for this additional funding award. Staff time and Historic Preservation Commission time is used for the match. Currently, there is sufficient time allocated to match the additional funds.

REQUEST: The Rapid City Historic Preservation Commission requests authorization of the Mayor and Finance Office to sign Amendment #2 to State of South Dakota Historical Preservation Allocation Award Between State Historical Preservation Office, Office of History and Rapid City Historic Preservation Commission Project SD-07-21 allocating additional funds in the amount of \$471.75.

WHEREAS, the State the state has additional funds to allocate towards the Subgrantee,

WHEREAS, the State agrees that such a change will be beneficial to the State in terms of promoting historic preservation in Rapid City;

NOW, THEREFORE, in consideration of the foregoing and the mutual covenants and agreements herein contained, and for other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree to amend the Allocation Award as follows:

- 1) Increase the federal share in the Workshop line item to \$471.75. Increase the match in the Workshop line item to \$471.75.

Except as hereby modified, the aforesaid Allocation Award shall otherwise be in full force and effect and is hereby expressly approved, ratified, and confirmed.
