Dear Kevin:

As we discussed, I have prepared an invoice for curation of the Duhamel Collection of Native American items. As you are aware, Minnilusa Historical Association has been displaying and curating the over 800 items in the Duhamel Native American Collection since the City acquired it from the Duhamel family in December of 1985.

In the past, Minnilusa was compensated for these services through a direct budget allocation from the City. In recent years, the Allied Arts Council has taken over the distribution of funds from the City to local Arts and humanities groups, including Minnilusa.

However, this year the Council chose not to fund Minnilusa. Consequently, Minnilusa has no resources to continue it's curation of the collection owned by the City. Enclosed you will find an invoice for those costs associated with curating the Duhamel Collection for one year. If the City chooses to discharge this obligation on a per month basis (\$412), please ensure that payments for the first 4 months of this year are included in the first payment.
