Subject: Authorization for Mayor and Finance Officer to Sign Addendum to Golf Concessionaire Agreement.

Summary: The Recreation Division is requesting authorization for the Mayor and Finance Officer to sign an addendum with B.F. Variety Store / DBA Matt Kimball's Golf Shop, to provide up to twenty hours of Meadowbrook Pro Shop coverage per week from September 1 to April 31 of each year under the contract.

Analysis/Background:

Duncan Olney Aquatics Division Manager (605) 394-5223 The Recreation Division has hours of operation that must be filled during the off season. This addendum will provide the Golf Recreation Coordinator/Specialist the flexibility to provide coverage under the contract for two days of operations during the off season. This will provide consistency in the Meadowbrook Golf Shop and allow for full coverage of the facility for better sales and customer service.

ADDENDUM TO PROFESSIONAL SERVICE AGREEMENT

The City of Rapid City ("City") and B.F. Variety Store, Inc. dba Matt Kimball's Golf Shop ("Professional") agree to the following amendment to the Professional Services Agreement entered into by the parties on March 19, 2008.

Paragraph 5 will be modified to read as follows:

- **5.** <u>Engagement.</u> The Professional shall be an independent contractor under this Agreement, and shall not be an employee of the City.
 - a. The city will collect all revenues for merchandise and lessons and the city will retain: Seven Percent (7%) of gross sales generated by merchandise sales, Seven Percent (7%) of gross sales generated by golf lessons, except those that are sponsored by the City Recreation Division.
 - b. City will collect all sales tax based on the States percentages and will remit those taxes to the State Department of Revenue.
 - c. The city will submit a payment request (minus the 7% gross on the concession, instruction, and sales tax withholding) each Friday for Concessionaire.
 - d. Bad credit card and bad checks for merchandise sold or lessons, will be considered bad debt and will be deducted from the following weeks gross sale receipts. The City will process bad checks through the City's collection services. Those Items collected will be paid to the concessionaire on the next gross sale receipt.
 - e. The loss of inventoried merchandise from the Pro Shop floor will be split equally between the City and Concessionaire and paid out at cost.
 - f. All furniture and fixtures located at Meadowbrook and Executive, and owned by the City, will remain the property of the City.
 - g. The Professional shall be compensated \$160.00 per week from September 1st to April 30th of each year to provide coverage in the Pro Shop for up to 20 hours per week. The professional and the Recreation Coordinator/Specialist will determine weekly schedule.

This Agreement may be terminated for cause at any time. This Agreement is not assignable and the death or disability of the principal Professional shall result in termination.
