Please confirm the reappointment of Steve Rolinger, representing Ward 4, Julie Gregg, representing Ward 5 and Karen Waltman, representing Ward 5 and Tom Hennies representing Ward 2 and Linda Marchand, representing Ward 1 as First Alternate Terms are three year terms and will run from July 1, 2008 to July 1, 2011.
