Executed by the undersigned for the purpose of forming a South Dakota Business Corporation under Chapter 47 of SDCL.

<u>FIRST</u>: The name of the corporation (the "Corporation") is Land Rush Properties, Inc.

SECOND: The period of existences is perpetual.

THIRD: The nature of the business or purposes to be conducted or promoted is as follows: to purchase, improve, develop, hold, and own real estate, and to lease, mortgage, and sell the same in such parts or parcels improved or unimproved, and on such terms as from time to time and manner of payment as the Corporation may, by its Board of Directors, agree.; and, to conduct or engage in any lawful act or activity for which corporations may be organized under the laws of South Dakota.

<u>FOURTH</u>: The total number of shares of capital stock which the Corporation shall have the authority to issue shall be 200,000 shares of Common Stock having a par value of \$.01 per share, amounting to an aggregate par value of \$2,000.00.

<u>FIFTH</u>: In furtherance of and not in limitation of powers conferred by statute, it is further provided that:

- (a) Subject to the limitations and exceptions, if any, contained in the by-laws of the Corporation, the by-laws may be adopted, amended or repealed by the Board of Directors of the Corporation;
- (b) Elections of directors need not be by written ballot;
- (c) Subject to any applicable requirements of law, the books of the Corporation may be kept outside the State of South Dakota at such locations as may be designated by the Board of Directors or in the by-laws of the Corporation; and
- (d) Except as provided to the contrary in the provisions establishing a class of stock, the number of authorized shares of such class may be increased or decreased (but not below the number of shares thereof then outstanding) by the affirmative vote of a majority of the stock of the Corporation entitled to vote, voting as a single class.
- (e) There shall be pre-emptive rights.

- (f) There shall be cumulative voting for directors.
- (g) The corporation will not commence business until consideration of the value of at least One Thousand Dollars (\$1,000.00) has been received for the issuance of shares.

SIXTH: Whenever a compromise or arrangement is proposed between the Corporation and its creditors or any class of them and/or between the Corporation and its stockholders or any class of them, any court of equitable jurisdiction within the State of South Dakota may, on the application in a summary way of the Corporation or of any creditor or stockholder thereof or on the application of any receiver or receivers appointed for the Corporation under the provisions of the South Dakota Code or on the application of trustees in dissolution or any receiver or receivers appointed for the Corporation under the provisions of the South Dakota Code order a meeting of the creditors or class of creditors, and/or of the stockholders or class of stockholders of the Corporation, as the case may be, to be summoned in such manner as the said court directs. If a majority in number representing three-fourths in value of the creditors or class of creditors, and/or of the stockholders or class of stockholders of the Corporation, as the case may be, agree to any compromise or arrangement and to any reorganization of the Corporation as a consequence of such compromise or arrangement, the said compromise or arrangement and the said reorganization shall, if sanctioned by the court to which the said application has been made, be binding on all the creditors or class of creditors, and/or on all the stockholders or class of stockholders, of the Corporation, as the case may be, and also on the Corporation.

SEVENTH: The Corporation shall indemnify to the fullest extent permitted by law any person who at any time is, or shall have been, a director or officer of the Corporation, and is threatened to be or is made a party to any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative or investigative (including an action, suit or proceeding by or in the right of the Corporation), by reason of the fact that he is, or was, a director, officer, employee or agent of the Corporation, or served at the request of the Corporation as a director, officer, employee, trustee or agent of another corporation, partnership, joint venture, trust or other enterprise, against expenses (including attorneys' fees), judgments, fines and amounts paid in settlement incurred in connection with any such action, suit or proceeding to the maximum extent permitted by the laws of South Dakota. The foregoing right of indemnification shall in no way be exclusive of any other rights of indemnification to which any such director, officer, employee or agent may be entitled, under any by-law, agreement, vote of directors or stockholders or otherwise.

<u>EIGHTH</u>: To the maximum extent permitted by the laws of the State of South Dakota, no director of the Corporation shall be personally liable to the Corporation or to any of its stockholders for monetary damages arising out of such director's breach of fiduciary duty as a director of the Corporation. No amendment or repeal of this Article

EIGHTH shall deprive a director of the benefits hereof with respect to any act or omission occurring prior to such amendment or repeal.

<u>NINTH</u>: The Corporation reserves the right to amend, alter, change or repeal any provision contained in this Certificate of Incorporation, in the manner now or hereafter prescribed by statute, and this Certificate of Incorporation and all rights conferred upon stockholders herein are granted subject to this reservation.

<u>TENTH</u>: The address of the registered office of the Corporation in the State of South Dakota is 2693D Commerce Road, Rapid City, South Dakota 57702, and the name of its registered agent at such address is George J. Nelson.
