No. LF041305-01 — Paula Mendeering told the Committee that they have been selling produce in Wyoming and South Dakota the past several years. They are trying to find a spot in Rapid City but keep running into problems. Pursuant to Rapid City ordinance, the Council has the discretion of recognizing them as a farmers market. This is their request. The people at the farmers market only allow local vendors. They don't want to cause ill feelings with the local growers. They would like to be allowed to be at the farmers market location on Fridays. Marcia Elkins told the Committee that the farmers market group has their own bylaws. They charge individual fees to persons wanting to sell their produce. They have gone through the 11-6-19 review process to be at their current location. Johnson moved to direct staff to visit with the Black Hills Farmers Market and bring back a recommendation regarding the request by Paula and Gary Mendeering to be recognized as a farmers market and to be allowed to sell produce at the farmers market location one day a week. Second by Waugh. Motion carried. Place item on consent calendar

Waugh moved to continue Karen Mortimer – parking related to Higher Education Center to the May 11, 2005, Legal and Finance Committee meeting. Second by Kroeger Motion carried.

Kroeger moved to approve Sioux Falls Water Ski Club's request to use Canyon Lake for a water ski show on June 25, 2005, and requested the club to contact the Fire Department regarding its refueling plans and emergency access plans and to include Jerry Cole, the Recreation Director, in the planning of this event.
